INTRODUCTION AND FIRST READING OF SENATE MEASURES

Senate Bill 9: By Senator Speier (Principal coauthor: Assembly Member Lieber)—An act to add Section 6259.1 to the Penal Code, relating to corrections.

Senate Bill 10: By Senator Machado—An act to add Chapter 3.21 (commencing with Section 15819.34) and Chapter 3.22 (commencing with Section 15819.38) to Part 10b of Division 3 of Title 2 of the Government Code, to amend Sections 7003, 7003.5, and 13602 of, to add Sections 7021 and 7004.5 to, and to add Chapter 9.8 (commencing with Section 6270) to Title 7 of Part 3 of, the Penal Code, and to repeal Section 2.5 of Chapter 1416 of the Statutes of 1987, relating to prisons, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.

Senate Bill 11: By Senators Machado and Runner—An act to add and repeal Section 3069 of the Penal Code, relating to parolees, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.

Senate Bill 12: By Senator Machado—An act to amend Section 2911 of the Penal Code, relating to inmate transfers.
