# CONSIDERATION OF DAILY FILE THIRD READING OF ASSEMBLY BILLS

**Assembly Bill 7**—An act to amend Section 16965 of, and to add Section 63048.66 to, the Government Code, to amend Sections 99312, 99312.7, and 99315 of the Public Utilities Code, and to amend Sections 7102 and 7104.2 of the Revenue and Taxation Code, relating to transportation, and declaring the urgency thereof, to take effect immediately.
