**INTRODUCTION AND FIRST READING OF SENATE MEASURES**

The following measures were introduced, read the first time and transmitted to the Committee on Rules:

**Senate Bill 21:** By Senator Ashburn—An act to add and repeal Section 17059.1 of the Revenue and Taxation Code, relating to taxation, to take effect immediately, tax levy.



**Senate Bill 22:** By Senators Padilla and Strickland (Coauthor: Senator Dutton)—An act to amend Section 26003 of, and to add Section 26011.7 to, the Public Resources Code, relating to energy.

**Senate Bill 23:** By Senator Hollingsworth—An act to amend Section 8504 of the Government Code, relating to state government.

#### **MEASURES WITHDRAWN FROM COMMITTEE**
