An act to add and repeal Article 6.3 (commencing with Section 54710) of Chapter 9 of Part 29 of Division 4 of Title 2 of the Education Code, relating to pupils.

LEGISLATIVE COUNSEL'S DIGEST

SB 890, as amended, Scott. Pupils: Early Commitment to College program.

Existing law requires a school district maintaining any of grades 7 to 12, inclusive, to offer to all otherwise qualified pupils in those grades a course of study fulfilling the requirements and prerequisites for admission to the California public institutions of postsecondary education and to provide a timely opportunity to each of those pupils to enroll within a 4-year period in each course necessary to fulfill those requirements and prerequisites.

Existing law authorizes a school district to apply to establish a University and College Opportunities Program with existing local or categorical funds. The program plan developed by a school district or school is required to include, among other things, college counseling to assist pupils in preparing application forms for college admission, to procure scholarships and other financial aid, and to meet all deadlines for these programs.

This bill would establish, until January 1, ~~2020~~ 2019, the Early Commitment to College program. Participation by pupils ~~and~~, school districts, *colleges, and universities* in the program would be voluntary. A pupil scheduled to graduate from high school after 2017 would not be allowed to participate. The Superintendent of Public Instruction would be required, among other program duties, to designate the 30% ~~of school districts that operate middle and high schools~~ *public schools that maintain any of grades 6 to 9, inclusive*, with the highest proportion of low-income pupils, as defined, as College Opportunity Zones. A school that is designated as a College Opportunity Zone by the Superintendent would be required to give all pupils enrolled in grades 6 to 9, inclusive, and their parents or guardians the opportunity to sign a "Save Me a Spot in College" pledge developed by the Superintendent. Schools not designated as a College Opportunity Zone would be required to give pupils who are eligible for free and reduced-price meals and are enrolled in grades 6 to 9, inclusive, and their parents or guardians the opportunity to sign a pledge. Participating school districts would be required to provide college information and college preparation events inclusive of pupils who sign the pledge.

The bill would provide that a pupil who signs a pledge declares a commitment to prepare for college, finish high school, and enroll in college and commits, among other things, to meet all graduation

requirements, take college preparatory coursework, complete and file a free application for federal student aid, and submit his or her grade point average to the Student Aid Commission by March 2 of his or her senior year. A pupil who signs the pledge and is certified by his or her school district as having fulfilled the requirements of the pledge would receive, upon enrollment at a community college, a fee waiver under the *fee waiver program of the Board of Governors of the California Community College Board of Governor's fee waiver program Colleges* for 2 or more years of enrollment at a California community college.

The bill would encourage the California Community Colleges, the University of California, the California State University, independent colleges and universities, the California Student Opportunity and Access Program, the Student Aid Commission, and other nonprofit, business, or other community organizations to provide support services as needed in coordination with local school districts.

The bill would require the Superintendent to submit a recommendation to the Legislature, on or before November 1, ~~2018~~ 2017, on whether the program should be continued.

These provisions would be repealed on January 1, 2019.

The people of the State of California do enact as follows:

1 SECTION 1. It is the intent of the Legislature to establish a
 2 program to ensure early notification and early commitment of
 3 college opportunities for pupils in middle school and high school
 4 and their families. It is the intent of the Legislature that the program
 5 motivate pupils to stay in school, graduate from high school, take
 6 college preparatory coursework, and, if they choose to do so, seek
 7 postsecondary opportunities.

8 SEC. 2. Article 6.3 (commencing with Section 54710) is added
 9 to Chapter 9 of Part 29 of Division 4 of Title 2 of the Education
 10 Code, to read:

 12 Article 6.3. Early Commitment to College Program

13
 14 54710. The Early Commitment to College program is hereby
 15 established for the purpose of accomplishing all of the following
 16 goals:

1 (a) Increase high school completion rates, direct college-going
2 rates, and college preparation of pupils attending schools with the
3 greatest poverty and among low-income pupils in general.

4 (b) Motivate pupils to prepare for college by taking college
5 preparatory coursework, which may include career technical
6 coursework and the course requirements for admission to the
7 University of California and the California State University.

8 (c) Help families understand that college is attainable and
9 affordable, that financial aid is available, and that with the right
10 preparation their children can go to college if they choose to do
11 so.

12 (d) Provide a clear path and direct assistance for pupils through
13 middle schools, high schools, community colleges, universities,
14 and state and federal financial aid programs, thereby improving
15 opportunity and efficiency.

16 (e) Strengthen the state's historic promise of college access
17 made in the 1960 Master Plan for Higher Education and express
18 this commitment directly to middle and high school pupils and
19 their families.

20 (f) Prepare the highly skilled workforce necessary to keep
21 California's economy competitive, maintain the income and quality
22 of life for California residents, increase tax revenues, and provide
23 for improved civic and democratic participation.

24 54711. (a) (1) Participation by pupils and school districts in
25 the Early Commitment to College program is voluntary. A school
26 district that chooses to participate in the program is encouraged to
27 do so districtwide, with all schools in the district participating, and
28 shall provide schoolwide college information and college
29 preparation events inclusive of pupils who sign the "Save Me a
30 Spot in College" pledge. An elementary school district may
31 distribute the general letter as set forth in subdivision (f) of Section
32 54712, but if the elementary school district chooses to participate
33 in the program, it shall do so in collaboration with the high school
34 district in which the predominant number of its pupils attend.

35 (2) *Participation by colleges and universities in the Early*
36 *Commitment to College program is voluntary.*

38 (3) For purposes of this article, all of the following apply:

39 (A) "College Opportunity Zone" means the 30 percent of ~~middle~~

2 of low-income pupils.

6 (4) Schools designated as a College Opportunity Zone in a
7 participating school district shall give all pupils enrolled in grades
8 6 to 9, inclusive, and their parents and guardians, the opportunity
9 to sign a “Save Me a Spot in College” pledge.

11 (5) Schools not designated as a College Opportunity Zone, in
12 a participating school district, shall give a pupil who is eligible for
13 free and reduced-price meals and is enrolled in grades 6 to 9,
14 inclusive, and his or her parent or guardian the opportunity to sign
15 a “Save Me a Spot in College” pledge.

16 (b) A participating school district shall certify that a pupil has
17 completed the “Save Me a Spot in College” pledge pursuant to
18 Section 54713, and shall track pupils enrolled in the Early
19 Commitment to College program by recording and reporting
20 participation and outcome data as directed by the Superintendent.

23 *or reduced-price meals in the National School Lunch Program* is
24 encouraged to participate in the Early Commitment to College
25 program.

27 shall not be allowed to enroll in the program.

28 54712. The Superintendent shall perform the following
29 responsibilities:

30 (a) Identify schools as College Opportunity Zones.

31 (b) Develop the “Save Me a Spot in College” pledge, which
32 shall include the commitments made by the pupil and the major
33 postsecondary and financial aid opportunities provided by the state.
34 *The pledge shall contain all of the following assurances:*

35 (1) *A pupil who signs the pledge and enrolls in the Early*
36 *Commitment to College program, in the same manner as all other*

8 (3) *In a manner that is consistent with Article 1 (commencing*
9 *with Section 76300) of Chapter 2 of Part 47 of Division 7 of Title*
10 *3, a pupil who signs the pledge shall receive, upon enrollment at*
11 *a community college, a fee waiver under the fee waiver program*
12 *of the Board of Governors of the California Community Colleges*
13 *for two or more years of enrollment at a campus of the California*
14 *Community Colleges, as long as the student is a California resident*
15 *and continues to show financial need on a completed Free*
16 *Application for Federal Student Aid.*

17 (c) Consult with the California Community Colleges, the
18 University of California, the California State University, the
19 Student Aid Commission, and independent colleges and universities
20 in developing the pledge, letter, and supporting materials, *including*
21 *a method for participating school districts to notify colleges and*
22 *universities in their service area that the school district is*
23 *participating in the program and seeking partnerships with*
24 *colleges, universities, and others to plan and conduct activities to*
25 *implement the program.*

26 (d) Determine the form of recognition for pupils who have been
27 certified by his or her school district as having fulfilled the
28 requirements of the pledge pursuant to subdivision (b) of Section
29 54711.

30 (e) Develop a method by which participating schools shall record
31 and report participation in, and outcome data of, the Early
32 Commitment to College program to the Superintendent pursuant
33 to subdivision (b) of Section 54711.

34 (f) (1) Develop a letter addressed to pupils enrolled in grades
35 6 to 9, inclusive, and their parents or guardians, and signed by the
36 ~~Governor, the Superintendent of Public Instruction, and the local~~
37 ~~district superintendent~~ *that by the Superintendent and the*
38 *superintendent of the school district that describes the major steps*
39 *to prepare for college, including postsecondary career technical*

1 education, and the major postsecondary and financial aid
2 opportunities available to students in California.

3 (2) Develop a second letter signed by the ~~Governor, the~~
4 ~~Superintendent of Public Instruction, and the local district~~

20 54713. (a) A pupil who signs a pledge declares a commitment
21 to prepare for college, finish high school, and enroll in college and
22 commits to do all of the following:

23 (1) Meet all graduation requirements to finish high school in
24 California.

25 (2) Enroll in college preparatory coursework, which may include
26 career technical coursework and the course requirements for
27 admission to the University of California and the California State
28 University.

29 (3) Seek to achieve proficiency in mathematics and in reading
30 and writing in English, as demonstrated by results on the ~~California~~
31 ~~Standards Test or Standardized Testing and Reporting Program~~
32 *pursuant to Section 60640. Pupils attending nonpublic schools,*
33 *which do not participate in the Standardized Testing and Reporting*
34 *Program pursuant to Section 60640, shall seek to achieve*
35 *proficiency in mathematics and reading and writing in English as*
36 *demonstrated by results on other assessments of college-level*
37 *readiness.*

38 (4) Complete and file a free application for federal student aid
39 and submit his or her grade point average to the Student Aid
40 Commission by March 2 of his or her senior year.

 2 admission or enroll directly in community college within 12 months
 3 after high school graduation.

29 54716. This article, ~~as of January 1, 2020,~~ *shall remain in effect*
 30 *only until January 1, 2019, and as of that date is repealed, unless*
 31 *a later enacted statute, that becomes operative on or before January*
 32 *1, ~~2020~~ 2019, deletes or extends that date.*
