ASSEMBLY BILL

No. 293

Introduced by Assembly Member Mendoza

An act to amend Sections 19804, 19805, 19824, 19841, 19846, 19851, 19852, 19868, 19880, 19882, 19890, 19892, 19893, 19900, 19912, 19921, 19932, 19941, and 19984 of, to amend the heading of Article 6 (commencing with Section 19890) of Chapter 5 of Division 8 of, and to add Sections 19890.5 and 19966 to, the Business and Professions Code, relating to gambling.

LEGISLATIVE COUNSEL'S DIGEST

AB 293, as amended, Mendoza. Gambling regulation.

(1) The Gambling Control Act provides for the licensure of certain individuals and establishments involved in various gambling activities, and for the regulation of those activities, by the California Gambling Control Commission. Existing law provides for the enforcement of those activities by the Department of Justice. Any violation of these provisions is punishable as a misdemeanor, as specified.

Existing law provides that no temporary injunction or other provisional order shall issue to restrain, stay, or otherwise interfere with any action by the department or the commission, except as specified, and that no order may be effective for more than 15 calendar days.

This bill instead would provide that, except for preliminary injunctions, no order may be effective for more than 15 calendar days, and no preliminary order may be effective for more than 45 days, except by stipulation of the department or commission.

(2) Existing law authorizes the commission, for any cause deemed reasonable by the commission, to deny any application for a license, permit, or approval, to limit, condition, or restrict any license, permit, or approval, or to impose any fine upon any person licensed or approved.

This bill would further authorize the commission to condition, restrict, discipline, or take action against the license of an individual owner endorsed on the license certificate of the gambling enterprise whether or not the commission takes action against the license of the gambling enterprise.

This bill would also expand the definition of “license” to include any license issued by the commission pursuant to or adopted pursuant to the Gambling Control Act.

(3) Existing law authorizes the commission to adopt regulations for the administration and enforcement of the Gambling Control Act. The regulations adopted by the commission are required to prohibit gambling establishments from cashing checks drawn against any federal, state, or county fund. Existing law requires gambling establishments to send the department copies of all dishonored or uncollectible checks at the end of each quarter.

This bill would require the regulations to prohibit gambling enterprises from cashing checks drawn against any federal, state, or county fund, and would delete the requirement that copies of dishonored or uncollectible checks be sent to the department. The bill also would require the regulations, by December 31, ~~2010~~ 2011, to provide procedures, criteria, and timelines for the processing and approval of applications for the licensing, temporary or interim licensing, or findings of suitability for receivers, trustees, beneficiaries, executors, administrators, conservators, successors in interest, or security interest holders for a gambling enterprise so that gambling enterprises may operate continuously in cases, including, but not limited to, the death, insolvency, foreclosure, receivership, or incapacity of a licensee.

(4) Existing law provides that the owner of a gambling enterprise shall apply for and obtain a state gambling license and other persons who obtain a state gambling license or key employee license shall not receive a separate license certificate.

This bill would designate the owner of a gambling enterprise as the owner-licensee, delete an obsolete cross reference, and make other conforming changes.

(5) Existing law provides that an owner of a gambling enterprise that is not a natural person shall not be eligible for a state gambling license unless certain persons individually apply for and obtain a state gambling license, except as specified.

This bill would define “gambling enterprise” for purposes of these provisions, and would require that, if the owner is a limited liability company, every officer, manager, member, or owner apply for and obtain a state gambling license as described above. The bill would make other conforming changes.

(6) Existing law requires the department to investigate an applicant for a gambling license. Existing law provides that, if denial of the application, or approval of the license with restrictions or conditions on the license, is recommended, the head of the entity within the department that is responsible for enforcing these provisions shall prepare and file with the commission his or her written reasons upon which the recommendation is based.

This bill would, in addition, require the head of that entity within the department to file with the commission the reasons for his or her recommendation if he or she recommends approval of the license with restrictions or conditions. The bill also would require the head of that entity to ~~prepare and file with the commission, if a restriction or condition on the license is recommended, his or her written reasons upon which the recommendation is based, including informing~~ *inform* the applicant in writing generally of the basis for any proposed recommendation that the application be restricted or conditioned, as specified.

(7) Existing law requires a corporation to comply with specified requirements in order to obtain a gambling license, including a requirement that the corporation register as a corporation with the department and supply specified supplemental information to the department.

This bill would instead require a corporation to supply supplemental forms and information with the initial license application, and thereafter only on request, to the department, as specified.

(8) Existing law requires the owner of any security issued by a corporation that applies for or holds an owner license to immediately

offer the security to the issuing corporation for purchase, if at any time the commission denies a license to the individual owner of the security.

This bill would instead require the commission, if at any time it denies a license to, or revokes the license of, an individual owner of any security issued by a corporation that applies for or holds an owner license, to immediately notify the individual and the corporation of that fact. The bill would require the owner of the security to sell the security, as specified.

(9) Existing law requires a limited partnership to comply with specified requirements in order to obtain a gambling license, including a requirement that the limited partnership be formed under the laws of this state.

This bill would impose on all partnerships the requirements for obtaining a gambling license that are applicable to limited partnerships, and would require that a partnership be registered as may be required under the laws of this state; instead of being formed under the laws of this state. The bill would modify other applicable requirements, including imposing on partnerships the requirement described in paragraph (6) relative to corporations. The bill would also require that limited liability companies comply with parallel requirements in order to obtain a gambling license.

(10) Under existing law, the purported sale, assignment, transfer, pledge, or other disposition of any interest in a limited partnership that holds a gambling license, or the grant of an option to purchase the interest, is void unless approved in advance by the commission. Existing law also requires the commission, if at any time it denies a license to an individual owner of any interest in a limited partnership that holds a gambling license, to immediately notify the partnership of that fact, and ~~would require~~ requires the partnership to return to the denied owner of the interest in cash the amount of his or her capital account, as specified.

This bill would make these provisions applicable to all partnerships and limited liability companies that hold a gambling license, would require the commission to give notice to the individual owner of the interest when it denies or revokes the license of the individual, and would require that individual to sell his or her interest, as specified.

(11) Existing law requires that, to the extent required by specified provisions of law, certain persons associated with a limited partnership that holds or applies for a license to own a gambling enterprise be licensed individually.

This bill would include members and managers among the persons to whom the above requirement applies and would impose the requirement, in addition, on those persons if they are associated with any partnership or limited liability company that holds or applies for a license to own a gambling enterprise.

(12) Existing law prohibits certain security interests from being enforced without the prior approval of the commission and compliance with certain regulations adopted by the department, including a security interest in a security issued by a partnership, except as specified. The department is required to adopt regulations establishing the procedure for the enforcement of a security interest.

This bill would, in addition, prohibit enforcement of a security interest without the above approval if the security interest is in a security issued by a limited partnership or limited liability company. The bill would instead require the commission to adopt those regulations.

(13) Existing law requires an order of the commission denying an application for a work permit to be reviewed in accordance with specified provisions of law.

This bill would, in addition, apply the above requirement to an order of the commission placing restrictions or conditions on a work permit.

(14) Existing law prohibits permitting any person under 21 years of age from entering upon the premises of a licensed gambling establishment, except for limited areas, as specified, and requires a separate entrance to those areas.

This bill would include among those exceptions a designated pathway to reach those permissible areas, would delete the requirement for a separate entrance, and would permit passage of a person under 21 years of age through the gaming floor by way of a designated pathway if accompanied by a person over 21 years of age or an employee of the gambling establishment.

(15) Existing law provides that any person aggrieved by a final decision or order of the commission that limits, conditions, suspends,

or revokes any previously granted license or approval, made after hearing by the commission, may petition the Superior Court for the County of Sacramento for judicial review pursuant to specified provisions of law. Existing law provides that the court may summarily deny the petition, or the court may issue an alternative writ directing the commission to certify the whole record of the department in the case to the court. Existing law requires that, if an alternative writ issues, the cause be heard on the whole record of the department as certified by the commission.

This bill would, instead, with respect to the above alternative writ, authorize the court to issue that writ to certify the whole record in the case to the court, and would require that, if the alternative writ issues, the cause be heard on the whole record as certified by the commission.

~~(15) Existing law provides that any licensee or employee in a gambling establishment who violates or permits the violation of specified prohibitions, including a provision prohibiting a person under 21 years of age from loitering in or about any room in which a gambling game is operated or conducted, is guilty of a crime.~~

~~This bill would eliminate the above crime as it applies to a licensee or employee in a gambling establishment who permits a person under 21 years of age from loitering as described above.~~

(16) The Gambling Control Act authorizes a city or county to permit controlled gambling, consistent with state law, if a majority of voters affirmatively approve an ordinance so permitting, as specified. That law authorizes an amendment of an ordinance permitting an expansion of gambling, within a specified limit, without voter approval, and also authorizes, without voter approval, an amendment to an ordinance permitting an increase of 24.99% in the number of gambling tables that may be operated in a gambling establishment or 2 gambling tables, whichever is greater, compared to the ordinance in effect on January 1, 1996.

This bill would authorize, if a gambling establishment is located in an unincorporated area annexed by a city without a local election other than the election to approve the annexation, the city acquiring jurisdiction to adopt an ordinance permitting and regulating controlled gaming in the existing gambling establishment, providing hours of operation, the games to be played, wagering limits, the maximum number of gambling establishments, and the maximum number of tables permitted in each gambling establishment, the same as those limits in

any ordinance or resolutions that formerly applied to the gambling establishment.

(17) Because any violation of these provisions would be punishable as a misdemeanor, the bill would impose a state-mandated local program by creating a new crime.

(18) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

The people of the State of California do enact as follows:

1 SECTION 1. Section 19804 of the Business and Professions
2 Code is amended to read:

3 19804. (a) In any action for declaratory or injunctive relief,
4 or for relief by way of any extraordinary writ, other than an action
5 initiated pursuant to Section 19932, wherein the construction,
6 application, or enforcement of this chapter, or any regulation
7 adopted pursuant thereto, or any order of the department or the
8 commission issued pursuant thereto, is called into question, a court
9 shall not grant any preliminary or permanent injunction, or any
10 peremptory writ of mandate, certiorari, or prohibition, in
11 connection therewith, except as follows:

12 (1) Upon proof by clear and convincing evidence that the
13 department or the commission is abusing or threatens to abuse its
14 discretion.

15 (2) Upon proof by clear and convincing evidence that the
16 department or the commission is exceeding or threatens to exceed
17 its jurisdiction.

18 (b) No temporary injunction or other provisional order shall
19 issue to restrain, stay, or otherwise interfere with any action by
20 the department or the commission, except upon a finding by the
21 court, based on clear and convincing evidence, that the public
22 interest will not be prejudiced thereby, and, except for preliminary
23 injunctions, no order may be effective for more than 15 calendar
24 days, except by stipulation of the department or commission. No

1 preliminary order may be effective for more than 45 days, except
2 by stipulation of the department or commission.

3 (c) This section does not relieve a petitioner's obligation to
4 exhaust administrative remedies.

5 (d) In an action for relief of any nature wherein the construction,
6 application, or enforcement of this chapter, or any regulation
7 adopted pursuant thereto, or any order of the department or
8 commission issued pursuant thereto, is called into question, the
9 party filing the pleading shall furnish a copy thereof to the
10 department and to the commission. The copy shall be furnished
11 by the party filing the pleading within 10 business days after filing.

12 SEC. 2. Section 19805 of the Business and Professions Code
13 is amended to read:

14 19805. As used in this chapter, the following definitions shall
15 apply:

16 (a) "Affiliate" means a person who, directly or indirectly through
17 one or more intermediaries, controls, is controlled by, or is under
18 common control with, a specified person.

19 (b) "Applicant" means any person who has applied for, or is
20 about to apply for, a state gambling license, a key employee license,
21 a registration, a finding of suitability, a work permit, a
22 manufacturer's or distributor's license, or an approval of any act
23 or transaction for which the approval or authorization of the
24 commission or department is required or permitted under this
25 chapter.

26 (c) "Banking game" or "banked game" does not include a
27 controlled game if the published rules of the game feature a
28 player-dealer position and provide that this position must be
29 continuously and systematically rotated amongst each of the
30 participants during the play of the game, ensure that the
31 player-dealer is able to win or lose only a fixed and limited wager
32 during the play of the game, and preclude the house, another entity,
33 a player, or an observer from maintaining or operating as a bank
34 during the course of the game. For purposes of this section, it is
35 not the intent of the Legislature to mandate acceptance of the deal
36 by every player if the department finds that the rules of the game
37 render the maintenance of or operation of a bank impossible by
38 other means. The house shall not occupy the player-dealer position.

1 (d) “Chief” means the head of the entity within the department
2 that is responsible for fulfilling the obligations imposed upon the
3 department by this chapter.

4 (e) “Commission” means the California Gambling Control
5 Commission.

6 (f) “Controlled gambling” means to deal, operate, carry on,
7 conduct, maintain, or expose for play any controlled game.

8 (g) “Controlled game” means any controlled game, as defined
9 by subdivision (e) of Section 337j of the Penal Code.

10 (h) “Department” means the Department of Justice.

11 (i) “Director” means any director of a corporation or any person
12 performing similar functions with respect to any organization.

13 (j) “Finding of suitability” means a finding that a person meets
14 the qualification criteria described in subdivisions (a) and (b) of
15 Section 19857, and that the person would not be disqualified from
16 holding a state gambling license on any of the grounds specified
17 in Section 19859.

18 (k) “Game” and “gambling game” means any controlled game.

19 (l) “Gambling” means to deal, operate, carry on, conduct,
20 maintain, or expose for play any controlled game.

21 (m) “Gambling enterprise” means ~~any person that owns a~~
22 ~~gambling operation~~ *a natural person or an entity, whether*
23 *individual, corporate, or otherwise, that conducts a gambling*
24 *operation and that by virtue thereof is required to hold a state*
25 *gambling license under this chapter.*

26 (n) “Gambling enterprise employee” means any natural person
27 employed in the operation of a gambling enterprise, including,
28 without limitation, dealers, floor personnel, security employees,
29 countroom personnel, cage personnel, collection personnel,
30 surveillance personnel, data-processing personnel, appropriate
31 maintenance personnel, waiters and waitresses, and secretaries, or
32 any other natural person whose employment duties require or
33 authorize access to restricted gambling establishment areas.

34 (o) “Gambling establishment,” “establishment,” or “licensed
35 premises,” except as otherwise defined in Section 19812, means
36 one or more rooms where any controlled gambling or activity
37 directly related thereto occurs.

38 (p) “Gambling license” or “state gambling license” means any
39 license issued by the state that authorizes the person named therein
40 to conduct a gambling operation.

1 (q) “Gambling operation” means exposing for play one or more
2 controlled games that are dealt, operated, carried on, conducted,
3 or maintained for commercial gain.

4 (r) “Gross revenue” means the total of all compensation received
5 for conducting any controlled game, and includes interest received
6 in payment for credit extended by an owner licensee to a patron
7 for purposes of gambling, except as provided by regulation.

8 (s) “Hours of operation” means the period during which a
9 gambling establishment is open to conduct the play of controlled
10 games within a 24-hour period. In determining whether there has
11 been expansion of gambling relating to “hours of operation,” the
12 department shall consider the hours in the day when the local
13 ordinance permitted the gambling establishment to be open for
14 business on January 1, 1996, and compare the current ordinance
15 and the hours during which the gambling establishment may be
16 open for business. The fact that the ordinance was amended to
17 permit gambling on a day, when gambling was not permitted on
18 January 1, 1996, shall not be considered in determining whether
19 there has been gambling in excess of that permitted by Section
20 19961.

21 (t) “House” means the gambling enterprise, and any owner,
22 shareholder, partner, key employee, or landlord thereof.

23 (u) “Independent agent,” except as provided by regulation,
24 means any person who does either of the following:

25 (1) Collects debt evidenced by a credit instrument.

26 (2) Contracts with an owner licensee, or an affiliate thereof, to
27 provide services consisting of arranging transportation or lodging
28 for guests at a gambling establishment.

29 (v) “Initial license” means the license first issued to a person
30 authorizing that person to commence the activities authorized by
31 that license.

32 (w) “Institutional investor” means any retirement fund
33 administered by a public agency for the exclusive benefit of federal,
34 state, or local public employees, any investment company
35 registered under the Investment Company Act of 1940 (15 U.S.C.
36 Sec. 80a-1 et seq.), any collective investment trust organized by
37 banks under Part Nine of the Rules of the Comptroller of the
38 Currency, any closed-end investment trust, any chartered or
39 licensed life insurance company or property and casualty insurance
40 company, any banking and other chartered or licensed lending

1 institution, any investment advisor registered under the Investment
2 Advisors Act of 1940 (15 U.S.C. Sec. 80b-1 et seq.) acting in that
3 capacity, and other persons as the commission may determine for
4 reasons consistent with the policies of this chapter.

5 (x) "Key employee" means any natural person employed in the
6 operation of a gambling enterprise in a supervisory capacity or
7 empowered to make discretionary decisions that regulate gambling
8 operations, including, without limitation, pit bosses, shift bosses,
9 credit executives, cashier operations supervisors, gambling
10 operation managers and assistant managers, managers or
11 supervisors of security employees, or any other natural person
12 designated as a key employee by the department for reasons
13 consistent with the policies of this chapter.

14 (y) "Key employee license" means a state license authorizing
15 the holder to be employed as a key employee.

16 (z) "License" means a gambling license ~~or, key employee license~~
17 *license, or any other license issued by the commission pursuant*
18 *to this chapter or regulations adopted pursuant to this chapter.*

19 (aa) "Licensed gambling establishment" means the gambling
20 premises encompassed by a state gambling license.

21 (ab) "Limited partnership" means a partnership formed by two
22 or more persons having as members one or more general partners
23 and one or more limited partners.

24 (ac) "Limited partnership interest" means the right of a general
25 or limited partner to any of the following:

26 (1) To receive from a limited partnership any of the following:

27 (A) A share of the revenue.

28 (B) Any other compensation by way of income.

29 (C) A return of any or all of his or her contribution to capital of
30 the limited partnership.

31 (2) To exercise any of the rights provided under state law.

32 (ad) "Owner licensee" means an owner of a gambling enterprise
33 who holds a state gambling license.

34 (ae) "Person," unless otherwise indicated, includes a natural
35 person, corporation, partnership, limited partnership, trust, joint
36 venture, association, or any other business organization.

37 (af) "Player" means a patron of a gambling establishment who
38 participates in a controlled game.

39 (ag) "Player-dealer" and "controlled game featuring a
40 player-dealer position" refer to a position in a controlled game, as

1 defined by the approved rules for that game, in which seated player
2 participants are afforded the temporary opportunity to wager
3 against multiple players at the same table, provided that this
4 position is rotated amongst the other seated players in the game.

5 (ah) “Publicly traded racing association” means a corporation
6 licensed to conduct horse racing and simulcast wagering pursuant
7 to Chapter 4 (commencing with Section 19400) whose stock is
8 publicly traded.

9 (ai) “Qualified racing association” means a corporation licensed
10 to conduct horse racing and simulcast wagering pursuant to Chapter
11 4 (commencing with Section 19400) that is a wholly owned
12 subsidiary of a corporation whose stock is publicly traded.

13 (aj) “Renewal license” means the license issued to the holder
14 of an initial license that authorizes the license to continue beyond
15 the expiration date of the initial license.

16 (ak) “Work permit” means any card, certificate, or permit issued
17 by the commission, or by a county, city, or city and county, whether
18 denominated as a work permit, registration card, or otherwise,
19 authorizing the holder to be employed as a gambling enterprise
20 employee or to serve as an independent agent. A document issued
21 by any governmental authority for any employment other than
22 gambling is not a valid work permit for the purposes of this chapter.

23 SEC. 3. Section 19824 of the Business and Professions Code
24 is amended to read:

25 19824. The commission shall have all powers necessary and
26 proper to enable it fully and effectually to carry out the policies
27 and purposes of this chapter, including, without limitation, the
28 power to do all of the following:

29 (a) Require any person to apply for a license, permit,
30 registration, or approval as specified in this chapter, or regulations
31 adopted pursuant to this chapter.

32 (b) For any cause deemed reasonable by the commission, deny
33 any application for a license, permit, or approval provided for in
34 this chapter or regulations adopted pursuant to this chapter, limit,
35 condition, or restrict any license, permit, or approval, or impose
36 any fine upon any person licensed or approved. The commission
37 may condition, restrict, discipline, or take action against the license
38 of an individual owner endorsed on the license *certificate* of the
39 gambling enterprise whether or not the commission takes action
40 against the license of the gambling enterprise.

1 (c) Approve or disapprove transactions, events, and processes
2 as provided in this chapter.

3 (d) Take actions deemed to be reasonable to ensure that no
4 ineligible, unqualified, disqualified, or unsuitable persons are
5 associated with controlled gambling activities.

6 (e) Take actions deemed to be reasonable to ensure that
7 gambling activities take place only in suitable locations.

8 (f) Grant temporary licenses, permits, or approvals on
9 appropriate terms and conditions.

10 (g) Institute a civil action in any superior court against any
11 person subject to this chapter to restrain a violation of this chapter.
12 An action brought against a person pursuant to this section does
13 not preclude a criminal action or administrative proceeding against
14 that person by the Attorney General or any district attorney or city
15 attorney.

16 (h) Issue subpoenas to compel attendance of witnesses and
17 production of documents and other material things at a meeting
18 or hearing of the commission or its committees, including advisory
19 committees.

20 SEC. 4. Section 19841 of the Business and Professions Code
21 is amended to read:

22 19841. The regulations adopted by the commission shall do
23 all of the following:

24 (a) With respect to applications, registrations, investigations,
25 and fees, the regulations shall include, but not be limited to,
26 provisions that do all of the following:

27 (1) Prescribe the method and form of application and
28 registration.

29 (2) Prescribe the information to be furnished by any applicant,
30 licensee, or registrant concerning, as appropriate, the person's
31 personal history, habits, character, associates, criminal record,
32 business activities, organizational structure, and financial affairs,
33 past or present.

34 (3) Prescribe the information to be furnished by an owner
35 licensee relating to the licensee's gambling employees.

36 (4) Require fingerprinting or other methods of identification of
37 an applicant, licensee, or employee of a licensee.

38 (5) Prescribe the manner and method of collection and payment
39 of fees and issuance of licenses.

1 (b) Provide for the approval of game rules and equipment by
2 the department to ensure fairness to the public and compliance
3 with state laws.

4 (c) Implement the provisions of this chapter relating to licensing
5 and other approvals.

6 (d) Require owner licensees to report and keep records of
7 transactions, including transactions as determined by the
8 department, involving cash or credit. The regulations may include,
9 without limitation, regulations requiring owner licensees to file
10 with the department reports similar to those required by Sections
11 5313 and 5314 of Title 31 of the United States Code, and by
12 Sections 103.22 and 103.23 of Title 31 of the Code of Federal
13 Regulations, and any successor provisions thereto, from financial
14 institutions, as defined in Section 5312 of Title 31 of the United
15 States Code and Section 103.11 of Title 31 of the Code of Federal
16 Regulations, and any successor provisions.

17 (e) Provide for the receipt of protests and written comments on
18 an application by public agencies, public officials, local governing
19 bodies, or residents of the location of the gambling establishment
20 or future gambling establishment.

21 (f) Provide for the disapproval of advertising by licensed
22 gambling establishments that is determined by the department to
23 be deceptive to the public. Regulations adopted by the commission
24 for advertising by licensed gambling establishments shall be
25 consistent with the advertising regulations adopted by the
26 California Horse Racing Board and the Lottery Commission.
27 Advertisement that appeals to children or adolescents or that offers
28 gambling as a means of becoming wealthy is presumptively
29 deceptive.

30 (g) Govern all of the following:

31 (1) The extension of credit.

32 (2) The cashing, deposit, and redemption of checks or other
33 negotiable instruments.

34 (3) The verification of identification in monetary transactions.

35 (h) Prescribe minimum procedures for adoption by owner
36 licensees to exercise effective control over their internal fiscal and
37 gambling affairs, which shall include, but not be limited to,
38 provisions for all of the following:

39 (1) The safeguarding of assets and revenues, including the
40 recording of cash and evidences of indebtedness.

1 (2) Prescribing the manner in which compensation from games
2 and gross revenue shall be computed and reported by an owner
3 licensee.

4 (3) The provision of reliable records, accounts, and reports of

30 (a) Any agreement, contract, or arrangement between a gambling
31 enterprise and a third-party provider of proposition player services
32 shall be approved in advance by the department, and in no event
33 shall a gambling enterprise or the house have any interest, whether
34 direct or indirect, in funds wagered, lost, or won.

35 (b) The commission shall establish reasonable criteria for, and
36 require the licensure and registration of, any person or entity that
37 provides proposition player services at gambling establishments
38 pursuant to this section, including owners, supervisors, and players.
