An act to amend Sections 18987.61 and 18987.62 of the Welfare and Institutions Code, relating to public social services.

LEGISLATIVE COUNSEL'S DIGEST

AB 488, as amended, Torres. Children's services programs: performance agreement contracts.

Under existing law, each county may enter into performance agreements with private, nonprofit agencies to encourage innovation in the delivery of children's services, to develop services not available in the community, and to promote change in the child welfare services system. Existing law limits these performance agreements to a period of 3 years.

This bill would authorize the ~~department~~ *State Department of Social Services* to renew or extend the performance agreements described above *for up to an additional 3 years* beyond the *original* 3-year time period and would make a conforming change.

The people of the State of California do enact as follows:

- 1 SECTION 1. Section 18987.61 of the Welfare and Institutions
- 2 Code is amended to read:

1 18987.61. (a) Each county may enter into performance
2 agreements with private, nonprofit agencies to encourage
3 innovation in the delivery of children's services, to develop services
4 not available in the community, and to promote change in the child
5 welfare services system.

6 (b) In developing the agreements, counties and service providers
7 shall pursue services that enhance the ability of children to remain
8 in the least restrictive, most family-like setting possible and
9 promote services that address the needs and strengths of individual
10 children and their families.

11 (c) Programs developed pursuant to this section shall operate
12 within the county, or in another county with the approval of that
13 county.

14 (d) Agreements pursuant to subdivision (a) shall be for a period
15 of up to three years, unless renewed or extended by the ~~department~~
16 *State Department of Social Services for up to an additional three*
17 *years.*

18 (e) A county shall provide a report to the director within three
19 months of the end of ~~each agreement~~ *the original agreement period*
20 to report on the details of the agreement, the results achieved during
21 its operation, and the applicability of the approach to a wider
22 population. The director shall make these reports available to the
23 Legislature upon request.

24 SEC. 2. Section 18987.62 of the Welfare and Institutions Code
25 is amended to read:

26 18987.62. (a) Upon request from a county, the director may
27 waive regulations governing foster care payments or the operation
28 of group homes to enable counties to implement the agreements
29 established pursuant to Section 18987.61. Waivers granted by the
30 director shall be applicable only to services provided under the
31 terms of the agreement and for the duration of the agreement,
32 including any renewal or extension authorized by the department.

33 A waiver shall only be granted when all of the following apply:

34 (1) The agreement promises to offer a worthwhile test of an
35 innovative approach or to encourage the development of a new
36 service for which there is a recognized need.

37 (2) The regulatory requirement prevents the implementation of
38 the agreement.

1 (3) The requesting county proposes to monitor the agreement
2 through performance measures that ensure that the purposes of the
3 waived regulation will be achieved.

4 (b) The director shall take steps that are necessary to prevent
5 the loss of any substantial amounts of federal funds as a result of
6 the waivers granted under this section. The waiver may specify
7 the extent to which the requesting county shall share in any cost
8 resulting from any loss of federal funding.

9 (c) The director shall not waive regulations that apply to the
10 health and safety of children served by participating private
11 agencies.

12 (d) The director shall notify the appropriate policy and fiscal
13 committees of the Legislature whenever waivers are granted and
14 when a waiver of regulations was required for the implementation
15 of the county's proposed agreement. The director shall identify
16 the reason why the development of the services outlined by the
17 agreement between the county and the service provider are hindered
18 by the regulations to be waived.
