An act to add and repeal Section 1257.10 of the Health and Safety Code, relating to health facilities.

LEGISLATIVE COUNSEL'S DIGEST

AB 911, as amended, Lieu. Emergency room crowding.

Existing law establishes various programs for the prevention of disease and the promotion of health to be administered by the State Department of Public Health, including, but not limited to, the licensure and regulation of health facilities, including general acute care, hospitals. Violation of these provisions is a crime.

This bill would require every licensed general acute care hospital with an emergency department to determine the range of crowding scores, as defined, that constitute each category of the crowding scale, as provided, for its emergency department. The bill would require every licensed general acute care hospital with an emergency department to calculate and record a crowding score every 4 hours, except as specified,

to assess the crowding condition of its emergency department. The bill would require, by January 1, 2011, every licensed general acute care hospital with an emergency department to develop and implement a full-capacity protocol for each of the categories of the crowding scale.

This bill would require every licensed general acute care hospital with an emergency department to file its full-capacity protocol with the Office of Statewide Health Planning and Development, and to annually report revisions to its protocol.

The bill would repeal its provisions on January 1, 2014.

By changing the definition of an existing crime, this bill would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

The people of the State of California do enact as follows:

- 1 SECTION 1. Section 1257.10 is added to the Health and Safety
- 2 Code, to read:
- 3 1257.10. (a) For purposes of this section, a “crowding score”
- 4 means the score calculated using the equation as follows: 85.8

- 18 (b) For purposes of this section the “crowding scale” means a
- 19 range of crowding scores that are divided into six categories of

1 which level one will be the lowest level of crowding and level six
2 will be the highest.

3 (c) Every licensed general acute care hospital, as defined in
4 subdivision (a) of Section 1250, with an emergency department
5 shall determine the range of crowding scores that constitute each
6 category of the crowding scale for its emergency department.

7 (d) (1) Except as otherwise provided in this subdivision, every
8 licensed general acute care hospital with an emergency department
9 shall calculate, and record, a crowding score a minimum of every
10 four hours to assess the crowding condition of its emergency
11 department.

12 (2) If, after calculating and recording a crowding score, a
13 licensed general acute care hospital does not have a crowding score
14 in level four or higher for the previous 30 days, it may calculate
15 and record a crowding score every eight hours rather than every
16 four hours. If the licensed general acute care hospital calculating
17 and recording a crowding score every eight hours records a score
18 in level four or higher, it shall again calculate and record a
19 crowding score every four hours.

20 (3) Any hospital that has an emergency department census of
21 less than ~~12,000~~ 14,000 visits annually shall calculate and record
22 the crowding score daily between 4 p.m. and 8 p.m.

23 (e) Every licensed general acute care hospital with an emergency
24 department shall, by January 1, 2011, develop and implement, in
25 consultation with its emergency department staff, a full-capacity
26 protocol for each of the categories of the crowding scale that
27 addresses all of the following factors, as applicable:

28 (1) Notification of hospital administrators, nursing staff, medical
29 staff, and ancillary services of category changes on the crowding
30 scale.

31 (2) Hospital operations, including bed utilization, transfers,
32 elective admissions, discharges, supplies, and additional staffing.

33 (3) Emergency department operations, including diversion,
34 triage, and alternative care sites.

35 ~~(4) Planned response, whether the response can be enforced by~~

38 *(4) The planned response of the organized medical staff for*
39 *rounds, discharges, coordination with the emergency department,*
40 *and emergency consults for emergency department patients.*

1 (f) Every licensed general acute care hospital with an emergency
2 department shall file its full-capacity protocol with the Office of
3 Statewide Health Planning and Development and shall annually
4 report any revisions to its protocol.

5 (g) This section shall remain in effect only until January 1, 2014,
6 and as of that date is repealed, unless a later enacted statute, that
7 is enacted before January 1, 2014, deletes or extends that date.

8 SEC. 2. No reimbursement is required by this act pursuant to
9 Section 6 of Article XIII B of the California Constitution because
10 the only costs that may be incurred by a local agency or school
11 district will be incurred because this act creates a new crime or
12 infraction, eliminates a crime or infraction, or changes the penalty
13 for a crime or infraction, within the meaning of Section 17556 of
14 the Government Code, or changes the definition of a crime within
15 the meaning of Section 6 of Article XIII B of the California
16 Constitution.
