An act to add Section 90001.5 to, to add Article 1.5 (commencing with Section 76010) to Chapter 1 of Part 47 of Division 7 of Title 3 of, and to add Article 6.5 (commencing with Section 92660) to Chapter 6 of Part 57 of Division 9 of Title 3 of, the Education Code, relating to foster youth.

LEGISLATIVE COUNSEL'S DIGEST

AB 1393, as introduced, Skinner. Foster youth.

(1) Existing law establishes the California Community Colleges, under the administration of the Board of Governors of the California Community Colleges. Existing law establishes community college districts throughout the state, and authorizes them to provide instruction to students at community college campuses.

This bill would request community college campuses to give priority for housing to current and former foster youth. The bill would also request community college campuses that maintain student housing facilities open for occupation during school breaks, or on a year-round basis, to give first priority to current and former foster youth for residence in the housing facilities that are open for uninterrupted year-round occupation, and next give priority to current and former foster youth for housing that is open for occupation during the most days in the calendar year.

(2) Existing law establishes the California State University and the University of California as 2 of the segments of public postsecondary education in this state. Existing law imposes certain requirements on the California State University with respect to student housing.

This bill would require a campus of the state university that maintains student housing facilities to give priority to current and former foster youth. The bill also would require a campus of the state university that maintains student housing facilities open for occupation during school breaks, or on a year-round basis, to give priority to current and former foster youth, as specified. The bill would apply similar provisions to the University of California only to the extent that the Regents of the University of California act, by resolution, to make it applicable.

The people of the State of California do enact as follows:

9 Colleges have stable housing, a campus of the California
10 Community Colleges is requested to give priority for housing to
11 current and former foster youth. In addition, a campus of the
12 California Community Colleges that maintains student housing
13 facilities open for occupation during school breaks, or on a
14 year-round basis, is requested to give first priority to current and
15 former foster youth for residence in the housing facilities that are
16 open for uninterrupted year-round occupation, and next give
17 priority to current and former foster youth for housing that is open
18 for occupation during the most days in the calendar year.

19 SEC. 2. Section 90001.5 is added to the Education Code, to

23 have stable housing, a campus of the California State University

16 92660. (a) In order to ensure that current and former foster
17 youth who are students at campuses of the University of California
18 have stable housing, a campus of the University of California that
19 maintains student housing facilities shall give priority to current
20 and former foster youth. In addition, a campus of the University
21 of California that maintains student housing facilities open for
22 occupation during school breaks, or on a year-round basis, shall
23 first give priority to current or former foster youth for residence
24 in the housing facilities that are open for uninterrupted year-round
25 occupation, and next give priority to current or former foster youth
26 for housing that is open for occupation during the most days in the
27 calendar year.

28 (b) Subdivision (a) shall not apply to the University of California
29 except to the extent that the Regents of the University of California,
30 by appropriate resolution, make that provision applicable.
