An act to add and repeal Section 4001 of the Elections Code, relating to elections.

LEGISLATIVE COUNSEL’S DIGEST

AB 1681, as amended, Yamada. Elections: all-mailed ballot elections.

Existing law authorizes a local, special, or consolidated election to be conducted as an all-mailed ballot election, so long as specified conditions are satisfied.

This bill would authorize as a pilot program, until December 31, ~~2016~~ 2014, elections in Yolo County, other than statewide primary or general elections or special elections to fill a vacancy in a state office, the Legislature, or Congress, to be conducted as all-mailed ballot elections if specified conditions are satisfied.

Vote: majority. Appropriation: no. Fiscal committee: no.
State-mandated local program: no.

The people of the State of California do enact as follows:

- 1 SECTION 1. Section 4001 is added to the Elections Code, to
- 2 read:
- 3 4001. (a) Notwithstanding Section 4000 *or any other provision*
- 4 *of law*, as a pilot program, elections in Yolo County may be
- 5 conducted as all-mailed ballot elections, subject to the following
- 6 conditions:

1 (1) The governing body of the city, county, or district, by
2 resolution, authorizes the all-mailed ballot election and notifies
3 the Secretary of State of its intent to conduct an all-mailed ballot
4 election at least 88 days prior to the date of the election.

5 (2) The election does not occur on the same date as a statewide
6 primary or general election or any other election conducted in an
7 overlapping jurisdiction that is not consolidated and conducted as
8 an all-mailed ballot election pursuant to this section.

9 (3) The election is not a special election to fill a vacancy in a
10 state office, the Legislature, or Congress.

11 (4) At least one polling place is provided ~~in each city within the~~
12 ~~jurisdiction~~ *per 10,000 registered voters* and is open to receive
13 voted ballots for ~~at least two~~ *four* weeks before the date of the
14 election and until 8 p.m. on the day of the election.

15 (5) The elections official delivers to each voter all supplies
16 necessary for the use and return of the mail ballot, including an
17 envelope for the return of the voted mail ballot, postage prepaid.

18 (6) The elections official delivers to each voter, with either the
19 sample ballot sent pursuant to Section 13303 or with the voter's
20 ballot, a list of the polling places provided pursuant to paragraph
21 (4), and this list is also posted on the Internet Web site of the
22 county elections office.

23 (7) The return of voted mail ballots is subject to Section 3017.

24 (8) The polling places provided under this section are at an
25 accessible location and are equipped with voting units or systems
26 that are accessible to individuals with disabilities and that provide
27 the same opportunity for access and participation, including the
28 ability to vote privately and independently.

29 (9) Elections pursuant to this section may be held on no more
30 than three different dates.

31 (b) (1) If the county conducts an all-mailed ballot election, on
32 or before December 31, ~~2016~~ *2014*, the county shall report to the
33 Legislature and to the Secretary of State regarding the success of
34 the election, including, but not limited to, any statistics on the cost
35 to conduct the election; the turnout of different populations,
36 including whenever possible, but not limited to, the population
37 categories of race, ethnicity, age, gender, disability, permanent
38 vote by mail status, and political party affiliation; the number of
39 ballots that are not counted and the reasons they were rejected;

1 voter fraud; and any other problems that become known to the
2 county during the election or canvass.

3 (2) Whenever possible, using the criteria set forth in paragraph
4 (1), the report of the county shall compare the success of the
5 all-mailed ballot election to similar elections not conducted as
6 all-mailed ballot elections in the same jurisdiction *or comparable*
7 *jurisdictions*.

8 (3) The report of the county shall be submitted to the Legislature
9 within six months after the date of the all-mailed ballot election
10 or prior to the date of any other all-mailed ballot election subject
11 to this section to be conducted in the county, whichever is sooner.

12 (c) This section shall remain in effect only until December 31,
13 ~~2016~~ 2014, and as of that date is repealed, unless a later enacted
14 statute, that is enacted before December 31, ~~2016~~ 2014, deletes or
15 extends that date.
