An act to add Sections 17053.76 and 23622.9 to the Revenue and Taxation Code, relating to taxation, to take effect immediately, tax levy.

LEGISLATIVE COUNSEL'S DIGEST

AB 1973, as amended, Swanson. Income taxes: credits: qualified employees.

The Personal Income Tax Law and the Corporation Tax Law authorize various credits against the taxes imposed by those laws, including a hiring credit for qualified taxpayers who hire qualified employees, as defined, subject to specified criteria.

This bill would, for taxable years beginning on or after January 1, 2010, authorize a hiring credit under those respective laws for taxpayers who hire qualified employees, as defined.

This bill would take effect immediately as a tax levy.

The people of the State of California do enact as follows:

- 1 **SECTION 1.** *This act shall be known and may be cited as the*

- 4 **SEC. 2.** Section 17053.76 is added to the Revenue and Taxation

1 17053.76. (a) (1) For each taxable year beginning on or after
2 January 1, 2010, there shall be allowed a credit against the “net
3 tax,” as defined in Section 17039, an amount as described in
4 paragraph (2), per each qualified employee employed by the
5 taxpayer during the taxable year.

6 (2) (A) Twenty percent of the gross salary for each qualified
7 employee employed by the taxpayer, not to exceed \$5,000, for the
8 first year of employment.

9 (B) Twenty percent of the gross salary for each qualified
10 employee employed by the taxpayer, not to exceed \$5,000, for the
11 second year of employment.

12 (b) The credit under subdivision (a) shall be allowed only with
13 respect to the first year of employment if the qualified employee
14 is employed by the taxpayer for 12 consecutive months from the
15 date of employment and only with respect to the second year of
16 employment if the qualified employee is employed by the taxpayer
17 for 24 consecutive months from the date of employment.

18 (c) For purposes of this section, “qualified employee” means
19 an individual who is an ex-offender employed by the taxpayer in
20 a part-time or full-time position. “Qualified employee” shall not
21 include an ex-offender who is required to register as a sex offender
22 pursuant to Section 290 of the Penal Code, or the equivalent in
23 another state or territory, under military law, or under federal law,
24 or was convicted of a serious or violent felony.

25 (d) Any deduction or credit otherwise allowed under this part
26 for the salaries paid or incurred by the taxpayer upon which the
27 credit is based shall be reduced by the amount of the credit.

30 following year, and succeeding years if necessary, until the credit

33 *SEC. 3.* Section 23622.9 is added to the Revenue and Taxation
34 Code, to read:

35 23622.9. (a) (1) For each taxable year beginning on or after
36 January 1, 2010, there shall be allowed a credit against the “tax,”
37 as defined in Section 23036, an amount as described in paragraph
38 (2), per each qualified employee employed by the taxpayer during
39 the taxable year.

1 (2) (A) Twenty percent of the gross salary for each qualified
2 employee employed by the taxpayer, not to exceed \$5,000, for the
3 first year of employment.

4 (B) Twenty percent of the gross salary for each qualified
5 employee employed by the taxpayer, not to exceed \$5,000, for the
6 second year of employment.

7 (b) The credit under subdivision (a) shall be allowed only with
8 respect to the first year of employment if the qualified employee
9 is employed by the taxpayer for 12 consecutive months from the
10 date of employment and only with respect to the second year of
11 employment if the qualified employee is employed by the taxpayer
12 for 24 consecutive months from the date of employment.

28 *SEC. 4.* This act provides for a tax levy within the meaning of
29 Article IV of the Constitution and shall go into immediate effect.
