An act to add Section 87 to the Military and Veterans Code, relating to veterans.

LEGISLATIVE COUNSEL'S DIGEST

AB 2785, as amended, Committee on Veterans Affairs. Department of Veterans Affairs: administration: agreements with other agencies.

Under existing law the Department of Veterans Affairs has specified powers and duties relating to military veterans, and the Secretary of Veterans Affairs is in charge of the department.

This bill would require the Secretary of Veterans Affairs, on or before June 30, 2011, and every year thereafter, to identify other state agencies and departments that offer or provide services to veterans, for the purpose of entering into formal agreements that specify the respective roles and activities of the entities.

Vote: majority. Appropriation: no. Fiscal committee: yes.
State-mandated local program: no.

The people of the State of California do enact as follows:

- 1 SECTION 1. The Legislature finds and declares the following:
- 2 (a) A 2009 audit performed by the State Auditor of the
- 3 Department of Veterans Affairs confirmed that the department

1 provides few direct services to veterans, outside of its veteran
2 homes and Cal Vet Home Loan Program, and that the department
3 has extremely limited interaction and few formal agreements with
4 other state agencies and other departments that could provide
5 additional services to veterans if done in a coordinated and efficient
6 manner.

7 (b) This dysfunction unfortunately comes at a critical time, with
8 California on the verge of experiencing the return of thousands of
9 soldiers from Operation Iraqi Freedom (OIF) and Operation
10 Enduring Freedom (OEF) who will need to be reintegrated back
11 into the workforce and the community. Many of ~~those~~ *these*
12 veterans will have served multiple tours of duty in combat zones
13 and thus will likely suffer from both physical and mental health
14 issues, such as post-traumatic stress disorder (PTSD) and traumatic
15 brain injury (TBI).

16 (c) The 2009 audit additionally noted that the strategic plan of
17 the department covering fiscal years 2007 to 2012, inclusive, is
18 incomplete and has not formally assessed the needs of veterans or
19 included key stakeholders in its strategic planning process, nor has
20 it effectively measured the department's progress towards meeting
21 the goals and objectives identified in the plan.

22 SEC. 2. Section 87 is added to the Military and Veterans Code,
23 to read:

24 87. On or before June 30, 2011, and every year thereafter, the
25 Secretary of Veterans Affairs shall identify other state agencies
26 and departments that offer or provide services to veterans, for the
27 purpose of entering into formal agreements that specify the
28 respective roles and activities of the entities.
