An act to amend Section 53086 of the Education Code, relating to career development.

LEGISLATIVE COUNSEL'S DIGEST

SB 123, as introduced, Liu. California Career Resource Network Program.

Existing law establishes the California Career Resource Network in state government for the purpose of providing career development information and resources to people in California in order to enable them to attain their career goals. The network is composed of the Director of Employment Development, the Superintendent of Public Instruction, the Chancellor of the California Community Colleges, the Director of Rehabilitation, the Director of Social Services, the Executive Director of the California Workforce Investment Board, the Executive Secretary of the Bureau for Private Postsecondary and Vocational Education, the Director of the California Youth Authority, the Director of the Department of Corrections and Rehabilitation, and the Director of the Department of Developmental Services, or their designees.

This bill would establish the network as a program in the State Department of Education, establish the State Agency Partners Committee to be composed of the members of the program, and require the State Agency Partners Committee to coordinate the use of network information and resources in its programs. These provisions would become operative on July 1, 2010.

The people of the State of California do enact as follows:

SECTION 1. Section 53086 of the Education Code is amended to read:

53086. (a) There is in ~~state government~~ *the department* the California Career Resource Network *Program*, formerly called the California Occupational Information Coordinating Committee; ~~composed of the Director of Employment Development, the Superintendent, the Chancellor of the California Community Colleges, the Director of Rehabilitation, the Director of Social Services, the Executive Director of the California Workforce Investment Board, the Executive Secretary of the Bureau for Private Postsecondary and Vocational Education, the Director of the California Youth Authority, the Director of the Department of Corrections, and the Director of the Department of Developmental Services, or their designees. This committee.~~ *This program* is established for the purposes of Section 2328 of Title 20 of the United States Code, for the purposes of this article, and for other purposes authorized by the Legislature.

(b) The mission of the ~~California Career Resource Network program~~ is to provide all persons in California with career development information and resources to enable them to reach their career goals.

(c) The primary duty of the ~~California Career Resource Network program~~ is to distribute career information, resources, and training materials to middle school and high school counselors, educators, and administrators, in order to ensure that middle schools and high schools have the necessary information available to provide a pupil with guidance and instruction on education and job requirements necessary for career development.

(d) Information and resources distributed by the ~~California Career Resource Network program~~ shall provide all of the following:

(1) Encouragement to completing a secondary education.

(2) Career exploration tools, provided in written and multimedia format, that offer an introduction to the nature of career planning, self-assessment, methods of investigating the work world, methods of identifying and meeting education and training needs, and methods of creating a career action plan.

1 (3) Relevant information on the labor market and career
