An act ~~relating to the Budget Act of 2011~~ to add Chapter 33 (commencing with Section 7599) to Division 7 of Title 1 of the Government Code, and to amend Sections 6051.7, 6201.7, 10752, 10752.1, 17041, 17054, and 7062 of, and to add Sections 7101.4, 10752.2, 11001.6, and 19136.14 to, the Revenue and Taxation Code, relating to local government finance, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.

LEGISLATIVE COUNSEL'S DIGEST

AB 18, as amended, Blumenfield. ~~Budget Act of 2011. The Schools and Local Public Safety Protection Act of 2011.~~

(1) Existing law, until July 1, 2011, imposes a state sales and use tax on retailers and on the storage, use, or other consumption of tangible personal property in this state at the rate of 7¼% of the gross receipts from the retail sale of tangible personal property in this state and of the sales price of tangible personal property purchased from any retailer for storage, use, or other consumption in this state. Existing law reduces the state sales and use tax rate by 1% on July 1, 2011.

The Vehicle License Fee Law establishes, until July 1, 2011, in lieu of any ad valorem property tax upon vehicles, an annual license fee for any vehicle subject to registration in this state in the amount of 1.15% of the market value of that vehicle, as provided. Existing law, on and after July 1, 2011, reduces that rate to 0.65%.

This bill would extend the existing sales and use tax rate and vehicle license fees until July 1, 2012, and would deposit the revenues derived from that extension into the Local Revenue Fund 2011, established by this bill, to be appropriated by the Legislature to fund the provision of public safety services, as described. This bill would require local county officials to create a County Local Revenue Fund 2011, and would require the money in County Local Revenue Fund 2011 to be used exclusively to fund the provision of public safety services by local agencies pursuant to the 2011 Realignment Legislation, as defined.

By imposing new duties upon local county officials with respect to the creation of the Local Revenue Fund 2011, this bill would impose a state-mandated local program.

This bill would additionally require, when the rates in the above-described taxes cease to be operative, the state to annually provide moneys in at least an equivalent amount to fund the provision of public safety services, and would make an appropriation for this purpose from the General Fund if the Legislature does not appropriate sufficient funds for this purpose and transfer the moneys, as specified.

(2) The Personal Income Tax Law imposes taxes based upon taxable income. That law also allows credits for personal exemptions, and imposes an alternative minimum tax, as specified. Existing law, for taxable years beginning on or after January 1, 2009, and before January 1, 2011, decreased the amount allowable as a credit for personal exemption for dependents, increased the tax rate applicable to taxable income, and increased the alternative minimum tax rate, as provided.

This bill would continue the decrease in the amount allowable as a credit for personal exemption for dependents for taxable years beginning on or after January 1, 2011, and before January 1, 2013, and would increase the tax rate applicable to taxable income and the alternative minimum tax rate for taxable years beginning on or after January 1, 2012, and before January 1, 2013. This bill would require the additional revenue received from the imposition of these tax rates and from the continuation of the credit amounts to be used exclusively for the support of school districts and community college districts.

(3) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state,

reimbursement for those costs shall be made pursuant to these statutory provisions.

(4) The California Constitution authorizes the Governor to declare a fiscal emergency and to call the Legislature into special session for that purpose. Governor Schwarzenegger issued a proclamation declaring a fiscal emergency, and calling a special session for this purpose, on December 6, 2010. Governor Brown issued a proclamation on January 20, 2011, declaring and reaffirming that a fiscal emergency exists and stating that his proclamation supersedes the earlier proclamation for purposes of that constitutional provision.

This bill would state that it addresses the fiscal emergency declared and reaffirmed by the Governor by proclamation issued on January 20, 2011, pursuant to the California Constitution.

(5) This bill would declare that it is to take effect immediately as an urgency statute.

This bill would express the intent of the Legislature to enact statutory changes relating to the Budget Act of 2011.

The people of the State of California do enact as follows:

- 1 SECTION 1. This act shall be known and may be cited as “The
- 2 Schools and Local Public Safety Protection Act of 2011.”
- 3 SEC. 2. The people find and declare the following:
- 4 (a) The chief purpose of this act is to protect schools and local
- 5 public safety by maintaining the level of certain taxes as they
- 6 existed in 2010. These taxes shall be placed in dedicated special

1 funds and be required to be used exclusively for schools and local
2 public safety.

3 (b) This act is part of a broader state budget plan that makes
4 billions of dollars in permanent cuts to state spending.

5 (c) This act guarantees solid, reliable funding for schools,
6 community colleges, and public safety.

7 (d) This act keeps sales and use taxes and vehicle license fees
8 at the same rates that were in effect in 2010, and requires that
9 these tax rates automatically drop to 2008 levels in one year, and
10 this act increases income taxes for one year beginning on or after
11 January 1, 2012, to the same rates that were in effect in 2010.
12 However, the extension of these tax increases may be retained for
13 a longer period if a constitutional amendment extending these
14 taxes is approved by the voters.

15 (e) This act also promotes transparency and supports improved
16 outcomes in the delivery of public safety services.

17 (f) All revenues from this act are subject to audit by the
18 independent Controller to ensure that they will be used only for
19 schools and local public safety.

20 (g) This act guarantees that local governments will continue to
21 receive funding for public safety services even after the tax rates
22 drop to their 2008 levels.

23 SEC. 3. Chapter 33 (commencing with Section 7599) is added
24 to Division 7 of Title 1 of the Government Code, to read:

29 *Article 1. Definitions*

31 7599. For the purposes of this chapter:

32 (a) "Public Safety Services" includes the following:

33 (1) Employing and training public safety officials, including
34 law enforcement personnel, attorneys assigned to criminal
35 proceedings, and court security staff.

36 (2) Managing local jails and providing housing, treatment, and
37 services for, and supervision of, juvenile and adult offenders.

38 (3) Preventing child abuse, neglect, or exploitation; providing
39 services to children who are abused, neglected, or exploited, or
40 who are at risk of abuse, neglect, or exploitation, and the families

1 of those children; providing adoption services, providing
2 transitional housing and other services to emancipated youth, and
3 providing adult protective services.

4 (4) Providing mental health services to children and adults to
5 reduce failure in school, harm to self or others, homelessness, and
6 preventable incarceration or institutionalization.

7 (5) Preventing, treating, and providing recovery services for
8 substance abuse.

9 (b) “2011 Realignment Legislation” means legislation enacted
10 on or before October 9, 2011, to implement the state budget plan,
11 that is entitled 2011 Realignment and provides for the assignment
12 of Public Safety Services responsibilities to local agencies,
13 including related reporting responsibilities. The legislation shall
14 provide local agencies with maximum flexibility and control over
15 the design, administration, and delivery of Public Safety Services
16 consistent with federal law and funding requirements.

18 Article 2. Local Revenue Fund 2011
19

20 7599.1. The Local Revenue Fund 2011 is hereby created in
21 the State Treasury. Notwithstanding Section 13340 of the
22 Government Code, funds deposited in the Local Revenue Fund
23 2011, less costs of administering the fund, are continuously
24 appropriated without regard to fiscal year exclusively to fund the
25 provision of Public Safety Services by local agencies and, pending
26 full implementation of the 2011 Realignment Legislation, to
27 reimburse the state for costs incurred in providing Public Safety
28 Services on behalf of local agencies. The manner of allocating
29 funds to local agencies and reimbursing state costs shall be
30 specified in the 2011 Realignment Legislation.

31 7599.2. The county treasurer, city and county treasurer, or
32 other appropriate official shall create a County Local Revenue
33 Fund 2011 within the treasury of each county or city and county.
34 The money in each County Local Revenue Fund 2011 shall be used
35 exclusively to fund the provision of Public Safety Services by local
36 agencies as specified by the 2011 Realignment Legislation.

37 7599.3. The funds deposited into a County Local Revenue Fund
38 2011 shall be spent in a manner designed to maintain the state’s
39 eligibility for federal matching funds, and to ensure compliance

1 by the state with applicable federal standards governing the state's
2 provision of Public Safety Services.

3 7599.4. The funds deposited into a County Local Revenue Fund
4 2011 shall not be used by local agencies to supplant other funding
5 for Public Safety Services.

6 7599.5. (a) When the taxes described in Sections 6051.7,
7 6201.7, 10752, and 10752.1 of the Revenue and Taxation Code,
8 as amended by the act adding this section, and in Section 10752.2
9 of the Revenue and Taxation Code, as added by the act adding
10 this section, cease to be operative, the state shall annually provide
11 moneys to the Local Revenue Fund 2011 in an amount equal to or
12 greater than the aggregate amount that otherwise would have been
13 provided by the above-described taxes. The method for determining
14 that amount shall be described in the 2011 Realignment
15 Legislation, and the state shall be obligated to provide that amount
16 for so long as the local agencies are required to perform the Public
17 Safety Services responsibilities assigned by the 2011 Realignment
18 Legislation.

19 (b) If the Legislature fails to annually appropriate the minimum
20 amount required by subdivision (a) to the Local Revenue Fund
21 2011, any shortfall, or the entire amount if no appropriation is
22 made by the Legislature, is hereby appropriated from the General
23 Fund, and the Controller shall transfer that amount from the
24 General Fund in pro rata monthly shares to the Local Revenue
25 Fund 2011. Thereafter, the Controller shall disburse these amounts
26 to local agencies in the manner directed by the 2011 Realignment
27 Legislation. The state obligations under this subdivision shall have
28 a lower priority claim to General Fund money than the first priority
29 for money to be set apart under Section 8 of Article XVI and the
30 second priority to pay voter-approved debts and liabilities
31 described in Section 1 of Article XVI.

32 7599.6. (a) Legislation enacted after October 9, 2011, that
33 has an overall effect of increasing the costs already borne by a
34 local agency for programs or levels of service mandated by the
35 2011 Realignment Legislation shall apply to local agencies only
36 to the extent that the state provides annual funding for the cost
37 increase. Local agencies shall not be obligated to provide
38 programs or levels of service required by legislation, described
39 in this article, above the level for which funding has been provided.

(b) Regulations, executive orders, or administrative directives, implemented after October 9, 2011, that are not necessary to implement the 2011 Realignment Legislation, and that have an overall effect of increasing the costs already borne by a local agency for programs or levels of service mandated by the 2011 Realignment Legislation, shall apply to local agencies only to the extent that the state provides annual funding for the cost increase. Local agencies shall not be obligated to provide programs or levels of service pursuant to new regulations, executive orders, or administrative directives, described in this subparagraph, above the level for which funding has been provided.

(c) The state shall not submit to the federal government any plans or waivers, or amendments to those plans or waivers, that have an overall effect of increasing the cost borne by a local agency for programs or levels of service mandated by the 2011 Realignment Legislation, except to the extent that the plans, waivers, or amendments are required by federal law, or the state provides annual funding for the cost increase.

7599.7. (a) For programs described in paragraphs (3) to (5), inclusive, of subdivision (a) of Section 7599 and included in the 2011 Realignment Legislation, if there are subsequent changes in federal statutes or regulations that alter the conditions under which federal matching funds as described in the 2011 Realignment Legislation are obtained, and have the overall effect of increasing the costs incurred by a local agency, the Legislature shall annually appropriate an amount equal to at least 50 percent of the nonfederal share of those costs as determined by the state from sources other than the 2011 Local Revenue Fund, the Education Protection Fund, ad valorem property taxes, or the Social Services Subaccount of the Sales Tax Account of the Local Revenue Fund for allocation to local agencies.

(b) When the state is a party to any complaint brought in a federal judicial or administrative proceeding that involves one or more of the programs described in paragraphs (3) to (5), inclusive, of subdivision (a) of Section 7599 and included in the 2011 Realignment Legislation, and there is a settlement or judicial or administrative order that imposes a cost in the form of a monetary penalty or has the overall effect of increasing the costs already borne by a local agency for programs or levels of service mandated by the 2011 Realignment Legislation, the Legislature shall

1 appropriate for allocation to local agencies an amount equal to
2 at least 50 percent of the nonfederal share of those costs as
3 determined by the state. Payment by the state is not required if the
4 state determines that the settlement or order relates to one or more
5 local agencies failing to perform a ministerial duty, failing to
6 perform a legal obligation in good faith, or acting in a negligent
7 or reckless manner.

8 7599.8. If the state or a local agency fails to perform a duty
9 or obligation under this chapter or under the 2011 Realignment
10 Legislation, an appropriate party may seek judicial relief. These
11 proceedings shall have priority over all other civil matters.

15 7599.9. The additional revenue received from the imposition
16 of the tax rates and from the continuation of the credit amounts
17 allowed pursuant to Sections 17041, 17054, and 17062 of the
18 Revenue and Taxation Code shall be used exclusively for the
19 support of school districts and community college districts.

21 Article 4. Audits

23 7599.10. The Controller, pursuant to his or her statutory
24 authority, may perform audits of expenditures from the Local
25 Revenue Fund 2011 and any County Local Revenue Fund 2011 to
26 ensure that those funds are used and accounted for in a manner
27 consistent with this chapter.

28 SEC. 4. Section 6051.7 of the Revenue and Taxation Code is
29 amended to read:

30 6051.7. (a) In addition to the taxes imposed by Section 6051
31 and any other provision of this part, for the privilege of selling
32 tangible personal property at retail, a tax is hereby imposed upon
33 all retailers at the rate of 1 percent of the gross receipts of any
34 retailer from the sale of all tangible personal property sold at retail
35 in this state, on and after April 1, 2009.

36 (b) This section shall cease to be operative on July 1, 2011,
37 unless the Director of Finance makes the notification pursuant to
38 Section 99040 of the Government Code, in which case this section
39 shall cease to be operative on July 1, 2012 2012.

SEC. 5. *Section 6201.7 of the Revenue and Taxation Code is amended to read:*

6201.7. (a) In addition to the taxes imposed by Section 6201 and any other provision of this part, an excise tax is hereby imposed on the storage, use, or other consumption in this state of tangible personal property purchased from any retailer for storage, use, or other consumption in this state, at the rate of 1 percent of the sales price of the property, on and after April 1, 2009.

(b) This section shall cease to be operative on July 1, 2011, unless the Director of Finance makes the notification pursuant to Section 99040 of the Government Code, in which case this section shall cease to be operative on July 1, 2012.

SEC. 6. *Section 7101.4 is added to the Revenue and Taxation Code, to read:*

7101.4. *Notwithstanding Section 7101, on and after July 1, 2011, all revenues, less refunds and costs of collection and deposit, derived from the taxes imposed by Sections 6051.7 and 6201.7 shall be deposited in the State Treasury to the credit of the Local Revenue Fund 2011, as established pursuant to Section 7599.1 of the Government Code.*

SEC. 7. *Section 10752 of the Revenue and Taxation Code, as amended by Section 4 of Chapter 18 of the Third Extraordinary Session of the Statutes of 2009, is amended to read:*

10752. (a) The annual amount of the license fee for any vehicle, other than a trailer or semitrailer, as described in subdivision (a) of Section 5014.1 of the Vehicle Code or a commercial motor vehicle described in Section 9400.1 of the Vehicle Code, or a trailer coach that is required to be moved under permit as authorized in Section 35790 of the Vehicle Code, shall be a sum equal to the following percentage of the market value of the vehicle as determined by the department:

as if the nonresident or part-year resident were a resident of this state for the taxable year and as if the nonresident or part-year resident were a resident of this state for all prior taxable years for any carryover items, deferred income, suspended losses, or suspended deductions, divided by the amount of that income.

(d) (1) There shall be imposed for each taxable year upon the taxable income of every nonresident or part-year resident when the nonresident or part-year resident is the head of a household, as defined in Section 17042, a tax as calculated in paragraph (2).

(2) The tax imposed under paragraph (1) shall be calculated by multiplying the “taxable income of a nonresident or part-year resident,” as defined in subdivision (i), by a rate (expressed as a percentage) equal to the tax computed under subdivision (c) on the entire taxable income of the nonresident or part-year resident as if the nonresident or part-year resident were a resident of this state for the taxable year and as if the nonresident or part-year resident were a resident of this state for all prior taxable years for any carryover items, deferred income, suspended losses, or suspended deductions, divided by the amount of that income.

(e) There shall be imposed for each taxable year upon the taxable income of every estate, trust, or common trust fund taxes equal to the amount computed under subdivision (a) for an individual having the same amount of taxable income.

(f) The tax imposed by this part is not a surtax.

(g) (1) Section 1(g) of the Internal Revenue Code, relating to certain unearned income of children taxed as if parent’s income, shall apply, except as otherwise provided.

(2) Section 1(g)(7)(B)(ii)(II) of the Internal Revenue Code is modified, for purposes of this part, by substituting “1 percent” for “10 percent.”

(h) For each taxable year beginning on or after January 1, 1988, the Franchise Tax Board shall recompute the income tax brackets prescribed in subdivisions (a) and (c). That computation shall be made as follows:

(1) The California Department of Industrial Relations shall transmit annually to the Franchise Tax Board the percentage change in the California Consumer Price Index for all items from June of the prior calendar year to June of the current calendar year, no later than August 1 of the current calendar year.

(2) The Franchise Tax Board shall do both of the following:

(A) Compute an inflation adjustment factor by adding 100 percent to the percentage change figure that is furnished pursuant to paragraph (1) and dividing the result by 100.

(B) Multiply the preceding taxable year income tax brackets by the inflation adjustment factor determined in subparagraph (A) and round off the resulting products to the nearest one dollar (\$1).

(i) (1) For purposes of this part, the term “taxable income of a nonresident or part-year resident” includes each of the following:

(A) For any part of the taxable year during which the taxpayer was a resident of this state (as defined by Section 17014), all items of gross income and all deductions, regardless of source.

(B) For any part of the taxable year during which the taxpayer was not a resident of this state, gross income and deductions derived from sources within this state, determined in accordance with Article 9 of Chapter 3 (commencing with Section 17301) and Chapter 11 (commencing with Section 17951).

(2) For purposes of computing “taxable income of a nonresident or part-year resident” under paragraph (1), the amount of any net operating loss sustained in any taxable year during any part of which the taxpayer was not a resident of this state shall be limited to the sum of the following:

(A) The amount of the loss attributable to the part of the taxable year in which the taxpayer was a resident.

(B) The amount of the loss which, during the part of the taxable year the taxpayer is not a resident, is attributable to California source income and deductions allowable in arriving at taxable income of a nonresident or part-year resident.

(3) For purposes of computing “taxable income of a nonresident or part-year resident” under paragraph (1), any carryover items, deferred income, suspended losses, or suspended deductions shall only be includable or allowable to the extent that the carryover item, deferred income, suspended loss, or suspended deduction was derived from sources within this state, calculated as if the nonresident or part-year resident, for the portion of the year he or she was a nonresident, had been a nonresident for all prior years.
