ASSEMBLY BILL

An act to add Chapter 7.75 (commencing with Section 3550) to Division 2 of the Business and Professions Code, relating to radiologist assistants.

LEGISLATIVE COUNSEL'S DIGEST

AB 352, as amended, Eng. Radiologist assistants.

Existing law, the Medical Practice Act, provides for the licensure and regulation of physicians and surgeons by the Medical Board of California. Existing law also provides for the certification and regulation of radiologic technologists by the State Department of Public Health.

This bill would enact the Radiologist Assistant Practice Act, which would require the licensure and regulation of radiologist assistants by the Radiologist Assistant Committee of the Medical Board of California and would prescribe the services that may be performed by a radiologist assistant under the direct supervision of a supervising radiologist, as defined. The bill would establish the Radiologist Assistant Committee of the Medical Board of California for purposes of implementing the act, the 7 members of which would be appointed by the Governor. The bill would require a radiologist assistant to meet specified licensure and programmatic requirements, including completion of an approved program that is certified by the committee, as specified. The bill would require a radiologist assistant to pay a licensure fee to be set by the committee and deposited into the Radiologist Assistant Fund which would be created by the bill in the State Treasury. The bill would make

it a crime for a person to practice as a radiologist assistant or osteopathic radiologist assistant without a license or for a radiologist assistant or osteopathic radiologist assistant to practice outside the scope of his or her practice, as specified, thereby imposing a state-mandated local program. The bill would ~~also establish a diversion program for the rehabilitation of radiologist assistants with drug or alcohol problems, and would set forth other disciplinary provisions and procedures.~~

This bill would require the committee to adopt regulations relating to the licensure and certification of radiologist assistants and approval of supervising radiologists and approved programs by July 1, 2012, and would require the committee to commence licensure and certification on that date or as soon as possible thereafter.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

The people of the State of California do enact as follows:

5 CHAPTER 7.75. RADIOLOGIST ASSISTANTS

7 Article 1. General Provisions

8
9 3550. (a) In its concern with the growing shortage and
10 geographic maldistribution of medical imaging health care services
11 in California, the Legislature intends to establish in this chapter a
12 framework for development of a new category of health manpower
13 designated as the radiologist assistant.

14 (b) The purpose of this chapter is to encourage the more
15 effective utilization of the skills of radiologists by enabling them
16 to delegate health care tasks to qualified radiologist assistants
17 where this delegation is consistent with the patient's health and

1 welfare and with the laws and regulations relating to radiologist
2 assistants.

3 (c) It is also the intent of this chapter to license radiologist
4 assistants and radiologist practitioner assistants and to categorize
5 both groups under the title of radiologist assistant.

6 (d) This chapter is established to encourage the utilization of
7 radiologist assistants by radiologists and to provide that existing
8 legal constraints should not be an unnecessary hindrance to the
9 more effective use of medical imaging health care services. It is
10 also the purpose of this chapter to allow for innovative development
11 of programs for the education, training, and utilization of
12 radiologist assistants.

13 3550.1. This chapter shall be known and cited as the
14 Radiologist Assistant Practice Act.

15 3550.2. As used in this chapter:

16 (a) "Approved program" means a radiologist assistant program
17 or a radiologist practitioner assistant program for the education
18 and training of radiologist assistants that has been formally
19 approved by the committee for the licensure of radiologist
20 assistants.

21 (b) "Board" means the Medical Board of California.

22 (c) "Committee" means the Radiologist Assistant Committee
23 of the Medical Board of California.

24 (d) "Direct supervision" means the supervising radiologist shall
25 be physically present on the premises and available to the
26 radiologist assistant when medical services are rendered.

27 (e) "Medical imaging" means any procedure intended for use
28 in the diagnosis or treatment of disease or other medical conditions,
29 and includes, but is not limited to, X-rays, nuclear medicine, and
30 other procedures, and that excludes echocardiography and
31 diagnostic sonography.

32 (f) "Program manager" means the staff manager of the diversion
33 program, as designated by the executive officer of the committee.
34 The program manager shall have background experience in dealing
35 with substance abuse issues.

36 (g) "Radiologist" means a physician and surgeon licensed by
37 the board or by the Osteopathic Medical Board of California and
38 certified by, or board-eligible for, the American Board of
39 Radiology.

1 (h) “Radiologist assistant” means a person who meets the
2 requirements of Section 3552.2 and the other requirements of this
3 chapter.

4 (i) “Radiology practitioner assistant” means a person who is
5 certified by the Certification Board for Radiology Practitioner
6 Assistants.

7 (j) “Regulations” means the rules and regulations as contained
8 in the California Code of Regulations.

9 (k) “Supervising radiologist” means a radiologist who is
10 approved by the committee as provided in this chapter and who
11 supervises one or more radiologist assistants.

12 (l) “Supervision” means that a certified radiologist oversees the
13 activities of, and accepts responsibility for, the medical services
14 rendered by a radiologist assistant.

15 3550.3. (a) Notwithstanding any other provision of law, a
16 radiologist assistant licensed pursuant to Section 3552.2 may
17 perform those medical services as set forth by the regulations of
18 the board when the services are rendered under the direct
19 supervision of a radiologist who meets the requirements of
20 subdivision (a) of Section 3550.4.

21 (b) (1) A radiologist assistant and his or her supervising
22 radiologist shall establish written guidelines for the adequate
23 supervision of the radiologist assistant. This requirement may be
24 satisfied by the supervising radiologist adopting protocols for some
25 or all of the tasks performed by the radiologist assistant.
26 Radiologist assistants shall not interpret images, make diagnoses,
27 or prescribe medications or therapies. The protocols adopted
28 pursuant to this subdivision shall comply with the following
29 requirements:

30 (A) A protocol governing procedures shall set forth the
31 information to be provided to the patient, the nature of the consent
32 to be obtained from the patient, the preparation and technique of
33 the procedure, supervision of radiologic technologists by the
34 radiologist assistant in the performance of medical imaging
35 procedures, and followup care.

36 (B) Protocols shall be developed by the supervising radiologist
37 or adopted from, or referenced to, texts or other sources.

38 (C) Protocols shall be signed and dated by the supervising
39 radiologist and the radiologist assistant.

1 (2) Notwithstanding any other provision of law, the board or
2 the committee may establish other alternative mechanisms for the
3 adequate supervision of the radiologist assistant.

4 (c) A radiologist assistant licensed under this chapter may
5 supervise a radiologic technologist in the performance of medical
6 imaging procedures using fluoroscopy and is exempted from the
7 provisions of Section 107110 of the Health and Safety Code and
8 Section 30463 of Title 17 of the California Code of Regulations.

9 3550.4. (a) Notwithstanding any other provision of law, a
10 radiologist assistant licensed by the committee shall be eligible
11 for employment or supervision by any supervising radiologist who
12 is approved by the committee. A supervising radiologist shall
13 possess a current and valid license to practice medicine and may
14 not be on disciplinary probation for improper use of a radiologist
15 assistant or subject to a disciplinary condition imposed by the
16 board prohibiting employment or supervision of a radiologist.

17 (b) No radiologist shall supervise more than two radiologist
18 assistants at any one time.

19 3550.5. (a) Notwithstanding any other provision of law, a
20 radiologist assistant may perform those medical services permitted
21 pursuant to Section 3550.3 during any state of war emergency,
22 state of emergency, or local emergency, as defined in Section 8558
23 of the Government Code, and at the request of a responsible federal,
24 state, or local official or agency, or pursuant to the terms of a
25 mutual aid operation plan established and approved pursuant to
26 the California Emergency Services Act (Chapter 7 (commencing
27 with Section 8550) of Division 1 of Title 2 of the Government
28 Code), regardless of whether the radiologist assistant's approved
29 supervising radiologist is available to supervise the radiologist
30 assistant, so long as a licensed physician and surgeon is available
31 to render the appropriate supervision. "Appropriate supervision"
32 shall not require the personal or electronic availability of a
33 supervising physician and surgeon if that availability is not possible
34 or practical due to the emergency. The local health officers and
35 their designees, who are licensed as physicians and surgeons, may
36 act as supervising physicians and surgeons during emergencies
37 without being subject to approval by the board.

38 (b) No responsible official or mutual aid operation plan shall
39 invoke this section except in the case of an emergency that
40 endangers the health of individuals. Under no circumstances shall

1 this section be invoked as the result of a labor dispute or other
2 dispute concerning collective bargaining.

3 3550.6. (a) A person licensed under this chapter who in good
4 faith renders emergency care at the scene of an emergency that
5 occurs outside both the place and course of that person's
6 employment shall not be liable for any civil damages as a result
7 of any acts or omissions by that person in rendering the emergency
8 care.

9 (b) This section shall not be construed to grant immunity from
10 civil damages to any person whose conduct in rendering emergency
11 care is grossly negligent.

12 (c) In addition to the immunity specified in subdivision (a), the
13 provisions of Article 17 (commencing with Section 2395) of
14 Chapter 5 shall apply to a person licensed under this chapter when
15 acting pursuant to delegated authority from an approved
16 supervising radiologist.

17 3550.7. No person other than one who has been licensed to
18 practice as a radiologist assistant shall practice as a radiologist
19 assistant or in a similar capacity to a radiologist or hold himself
20 or herself out as a "radiologist assistant."

22 Article 2. Administration
23

24 3551. There is established a Radiologist Assistant Committee
25 of the Medical Board of California. The committee consists of
26 seven members.

27 3551.1. Protection of the public shall be the highest priority
28 for the Radiologist Assistant Committee of the Medical Board of
29 California in exercising its licensing, regulatory, and disciplinary
30 functions. Whenever the protection of the public is inconsistent
31 with other interests sought to be promoted, the protection of the
32 public shall be paramount.

33 3551.2. (a) The members of the committee shall include a
34 member of the board, a physician and surgeon representative of a
35 California medical school who is a radiologist, an educator
36 participating in an approved program for the education of
37 radiologist assistants, a radiologist who is not a member of the
38 board, two radiologist assistants, one of whom is certified as a
39 radiologist assistant by the American Registry of Radiologic

1 Technologists and one of whom is certified by the Certification
2 Board for Radiology Practitioner Assistants, and a public member.

3 (b) Each member of the committee shall hold office for a term
4 of four years expiring on January 1, and shall serve until the
5 appointment and qualification of a successor or until one year shall
6 have elapsed since the expiration of the term for which the member
7 was appointed, whichever first occurs. No member shall serve for
8 more than two consecutive terms. Vacancies shall be filled by
9 appointment for the unexpired terms.

10 (c) The Governor shall appoint each of the members of the
11 committee.

12 3551.3. The committee shall elect annually a chairperson and
13 a vice chairperson from among its members.

14 3551.4. Each member of the committee shall receive a per
15 diem and expenses as provided in Section 103.

16 3551.5. The Governor may remove from office any member
17 of the committee, as provided in Section 106.

18 3551.6. (a) The committee may convene from time to time as
19 deemed necessary by the committee.

20 (b) Notice of each meeting of the committee shall be given at
21 least two weeks in advance to those persons who and organizations
22 that express an interest in receiving notification.

23 (c) The committee shall receive permission of the director to
24 meet more than six times annually. The director shall approve
25 meetings that are necessary for the committee to fulfill its legal
26 responsibilities.

27 3551.7. It shall be the duty of the committee to do all of the
28 following:

29 (a) Establish standards and issue licenses for approved programs.

30 (b) Make recommendations to the board concerning the scope
31 of practice for radiologist assistants using the guidance of the
32 American Society of Radiologic Technologists, the American
33 Registry of Radiologic Technologists, the American College of
34 Radiology, and the Certification Board for Radiology Practitioner
35 Assistants.

36 (c) Make recommendations to the board concerning the
37 formulation of guidelines for the consideration of applications by
38 radiologists to supervise radiologist assistants and approval of
39 those applications.

1 (d) Require the licensure of radiologist assistant applicants who
2 meet the requirements of this chapter.

3 (e) Adopt regulations pursuant to Section 3552.1.

4 3551.8. The committee may adopt, amend, and repeal
5 regulations as may be necessary to enable it to carry into effect
6 the provisions of this chapter; provided, however, that the board
7 shall adopt, amend, and repeal such regulations as may be
8 necessary to enable it to implement the provisions of this chapter
9 under its jurisdiction. All regulations shall be in accordance with,
10 and not inconsistent with, the provisions of this chapter. All
11 regulations shall be adopted, amended, or repealed in accordance
12 with the provisions of Chapter 3.5 (commencing with Section
13 11340) of Part 1 of Division 3 of Title 2 of the Government Code.

14 3551.9. Four members of the committee shall constitute a
15 quorum for transacting any business. The affirmative vote of a
16 majority of those present at a meeting of the committee shall be
17 required to carry any motion.

18 3552. Except as provided in Sections 159.5 and 2020, the
19 committee shall employ within the limits of the Radiologist
20 Assistant Fund all personnel necessary to carry out the provisions
21 of this chapter, including an executive officer who shall be exempt
22 from civil service. The board and committee shall make all
23 necessary expenditures to carry out the provisions of this chapter
24 from the fund established by Section 3553. The committee may
25 accept contributions to effect the purposes of this chapter.

26 Article 3. Licensure and Certification

27
28
29 3552.1. (a) The committee shall adopt regulations consistent
30 with Sections 3551.7 and 3552.2 for the consideration of
31 applications for licensure as a radiologist assistant.

32 (b) The committee shall adopt regulations consistent with
33 Sections 3551.7 and 3552.3 for the certification of approved
34 programs.

35 (c) The committee shall adopt regulations consistent with
36 Sections 3550.4 and 3551.7 for the approval of supervising
37 radiologists.

38 (d) The committee shall adopt the regulations described in this
39 section no later than July 1, 2012.

1 3552.2. Commencing July 1, 2012, or as soon as possible
2 thereafter, the committee shall issue under the name of the board
3 a license to each radiologist assistant applicant who meets all of
4 the following requirements:

5 (a) Provides evidence of successful completion of an approved
6 program.

7 (b) Is certified as a radiologist assistant by the American
8 Registry of Radiologic Technologists or as a radiology practitioner
9 assistant by the Certification Board for Radiology Practitioner
10 Assistants.

11 (c) Is ~~licensed~~ *certified* by the State Department of Public Health
12 as a diagnostic radiologic technologist and holds a radiologic
13 technologist fluoroscopy permit.

14 (d) Is not subject to denial of licensure under Division 1.5
15 (commencing with Section 475) or Section 3554.

16 (e) Pays all fees required under Section 3553.1.

17 3552.3. Commencing July 1, 2012, or as soon as possible
18 thereafter, the committee shall approve training programs for
19 radiologist assistants housed in academic institutions accredited
20 by a regional accrediting organization. The committee may
21 examine and issue certificates to approved programs that satisfy
22 the requirements of the regulations described in Section 3552.1.

23 3552.3.5. Commencing July 1, 2012, or as soon as possible
24 thereafter, the committee shall issue approvals to supervising
25 radiologists meeting the requirements of this chapter and the
26 regulations promulgated hereunder.

27 3552.4. (a) Every radiologist assistant applicant who has
28 complied with subdivision (a) of Section 3552.2 and has filed an
29 application with the committee may, between the date of receipt
30 of notice that the application is on file and the date of receipt of
31 his or her license, practice as a radiologist assistant on interim
32 approval under the supervision of a supervising radiologist. Prior
33 to practicing under interim approval, applicants shall notify the
34 committee in writing of any and all supervising radiologists under
35 whom they will be performing services. If the applicant fails to
36 take the next succeeding certification examination, fails to pass
37 the examination, or fails to receive a license, all privileges under
38 this section shall automatically cease upon written notification
39 sent to the applicant by the committee.

(b) The applicant shall provide evidence satisfactory to the committee that an application has been filed and accepted for the examination and that the organization certifying radiologist assistants has been requested to verify the applicant's certification status to the committee in order for the applicant to maintain interim approval. The applicant shall be deemed to have failed the examination unless the applicant provides evidence to the committee within 30 days after scores have been released that he or she has passed the examination.

3552.5. (a) The committee may issue under the name of the board a probationary license to a radiologist assistant applicant subject to terms and conditions, including, but not limited to, any of the following conditions of probation:

(1) Practice is limited to a supervised, structured environment where the applicant's activities are supervised by another radiologist assistant.

(2) Continuing medical or psychiatric treatment.

(3) Ongoing participation in a specified rehabilitation program.

(4) Enrollment in and successful completion of a clinical training program.

(5) Abstention from the use of alcohol or drugs.

(6) Restrictions against engaging in certain types of medical services.

(7) Compliance with all provisions of this chapter.

(b) The committee and the board may modify or terminate the terms and conditions imposed on the probationary license upon receipt of a petition from the licensee.

(c) Enforcement and monitoring of the probationary conditions shall be under the jurisdiction of the committee and the board.

(d) These proceedings shall be conducted in accordance with Chapter 5 (commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

3552.6. The committee shall keep current, two separate registers, one for approved supervising radiologists and one for licensed radiologist assistants. These registers shall show the name of each licensee, his or her last known address of record, and the date of his or her approved supervising radiologist and each approval or licensure, including those persons practicing under interim approval pursuant to Section 3552.4. Any interested person may obtain a copy of a register in accordance with the Information

Practices Act of 1977 (Chapter 1 (commencing with Section 1798) of Title 1.8 of Part 4 of Division 3 of the Civil Code) upon application to the committee together with a sum as may be fixed by the committee, which amount shall not exceed the cost of the register so furnished.

Article 4. Revenue

3553. Within 10 days after the beginning of each calendar month, the board shall report to the Controller the amount and source of all collections made under this chapter and at the same time pay all those sums into the State Treasury, where they shall be credited to the Radiologist Assistant Fund, which fund is hereby created. All money in the fund shall, upon appropriation by the Legislature, be used to carry out the purpose of this chapter.

3553.1. Fees to be paid by radiologist assistants and supervising radiologists for licensure, approval, and renewal shall be set by the committee in an amount sufficient to cover the reasonable and necessary costs of implementing and administering this chapter.

3553.2. The committee shall report to the appropriate policy and fiscal committees of each house of the Legislature whenever the board approves a fee increase pursuant to Section 3553.1.

3553.3. (a) An approval to supervise radiologist assistants shall expire at 12 midnight on the last day of the birth month of the radiologist assistant during the second year of a two-year term if not renewed.

(b) The board shall establish a cyclical renewal program, including, but not limited to, the establishment of a system of staggered expiration dates for approvals and a pro rata formula for the payment of renewal fees by supervising radiologists.

(c) To renew an unexpired approval, the supervising radiologist, on or before the date of expiration, shall apply for renewal on a form prescribed by the board and pay the prescribed renewal fee.

3553.4. (a) All radiologist assistant licenses shall expire at 12 midnight of the last day of the birth month of the licensee during the second year of a two-year term if not renewed.

(b) The committee shall establish by regulation procedures for the administration of a birth date renewal program, including, but not limited to, the establishment of a system of staggered license expiration dates.

1 (c) To renew an unexpired license, the licensee shall, on or
2 before the date of expiration of the license, apply for renewal on
3 a form provided by the committee, accompanied by the prescribed
4 renewal fee.

5 3553.5. The committee shall require a licensee to complete
6 continuing education, as deemed acceptable by the committee, as
7 a condition of license renewal under Section 3553.4. The
8 committee shall not require more than 50 hours of continuing
9 education every two years.

10 3553.6. (a) A suspended license is subject to expiration and
11 shall be renewed as provided in this chapter, but that renewal does
12 not entitle the holder of the license, while it remains suspended
13 and until it is reinstated, to practice or engage in the activity to
14 which the license relates, or engage in any other activity or conduct
15 in violation of the order or judgment by which the license was
16 suspended.

17 (b) A revoked license is subject to expiration as provided in this
18 chapter. If the license is reinstated after expiration, the licensee,
19 as a condition to reinstatement, shall pay a reinstatement fee in an
20 amount equal to the renewal fee in effect on the last preceding
21 regular renewal date before the date on which it is reinstated.

22 Article 5. Denial, Suspension, and Revocation

23

25 3554. (a) The committee may deny, issue with terms and
26 conditions, suspend or revoke, or impose probationary conditions
27 upon a radiologist assistant license after a hearing as required in
28 Section 3554.1 for unprofessional conduct that includes, but is not
29 limited to, a violation of this chapter, a violation of the Radiologic
30 Technology Act, as defined in Section 27 of the Health and Safety
31 Code, a violation of the applicable regulations adopted by the
32 committee or the board, or a breach of an ethics rule established
33 by a recognized national certification organization of radiologist
34 assistants.

35 (b) The committee may deny, approve with terms and
36 conditions, suspend or revoke, or impose probationary conditions
37 upon an approved program after a hearing as required in Section
38 3554.1 for a violation of this chapter or the regulations adopted
39 pursuant to this chapter.

1 (c) The committee may deny, approve with terms and conditions,
2 suspend or revoke, or impose probationary conditions upon an
3 approval of a supervising radiologist to supervise a radiologist
4 assistant, after a hearing as required in Section 3554.1, for
5 unprofessional conduct, which includes, but is not limited to, a
6 violation of this chapter, a violation of the Medical Practice Act,
7 or a violation of the regulations adopted by the committee or the
8 board.

9 (d) Notwithstanding subdivision (c), the board, in conjunction
10 with an action it has commenced against a radiologist, may order
11 the suspension or revocation of, or the imposition of probationary
12 conditions upon, an approval of a supervising radiologist to
13 supervise a radiologist assistant, after a hearing as required in
14 Section 3554.1, for unprofessional conduct, which includes, but
15 is not limited to, a violation of this chapter, a violation of the
16 Medical Practice Act, or a violation of the regulations adopted by
17 the committee or the board.

18 (e) The committee may deny, approve with terms and conditions,
19 suspend or revoke, or impose probationary conditions upon, a
20 radiologist assistant license, after a hearing as required in Section
21 3554.1, for unprofessional conduct that includes, except for good
22 cause, the knowing failure of a licensee to protect patients by
23 failing to follow infection control guidelines of the committee,
24 thereby risking transmission of bloodborne infectious diseases
25 from licensee to patient, from patient to patient, and from patient
26 to licensee. In administering this subdivision, the committee shall
27 consider referencing the standards, regulations, and guidelines of
28 the State Department of Public Health developed pursuant to
29 Section 1250.11 of the Health and Safety Code and the standards,
30 regulations, and guidelines pursuant to the California Occupational
31 Safety and Health Act of 1973 (Part 1 (commencing with Section
32 6300) of Division 5 of the Labor Code) for preventing the
33 transmission of HIV, hepatitis B, and other bloodborne pathogens
34 in health care settings. As necessary, the committee shall consult
35 with the board to encourage appropriate consistency in the
36 implementation of this subdivision. The committee shall seek to
37 ensure that licensees are informed of the responsibility of licensees
38 and others to follow infection control guidelines, and of the most
39 recent scientifically recognized safeguards for minimizing the risk
40 of transmission of bloodborne infectious diseases.

1 (f) The committee may order the licensee to pay the costs of
2 monitoring the probationary conditions imposed on the license.

3 3554.1. Any proceedings involving the denial, suspension, or
4 revocation of the application for licensure or the license of a
5 radiologist assistant, the application for approval or the approval
6 of a supervising radiologist, or the application for approval or the
7 approval of an approved program under this chapter shall be
8 conducted in accordance with Chapter 5 (commencing with Section
9 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

10 3554.2. The committee may hear any matters filed pursuant to
11 subdivisions (a) and (b) of Section 3554, or may assign any such
12 matter to a hearing officer. The board may hear any matters filed
13 pursuant to subdivision (c) of Section 3554, or may assign any
14 such matter to a hearing officer. If a matter is heard by the
15 committee or the board, the hearing officer who presided at the
16 hearing shall be present during the committee's or board's
17 consideration of the case, and, if requested, assist and advise the
18 committee or the board.

19 3554.3. (a) A person whose license or approval has been
20 revoked or suspended, or who has been placed on probation, may
21 petition the committee for reinstatement or modification of penalty,
22 including modification or termination of probation, after a period
23 of not less than the following minimum periods has elapsed from
24 the effective date of the decision ordering that disciplinary action:

25 (1) At least three years for reinstatement of a license or approval
26 revoked for unprofessional conduct, except that the committee

29 (2) At least two years for early termination of probation of three

31 (3) At least one year for modification of a condition,

34 (b) The petition shall state any facts as may be required by the
35 board. The petition shall be accompanied by at least two verified
36 recommendations from radiologists licensed either by the board
37 or the Osteopathic Medical Board of California who have personal
38 knowledge of the activities of the petitioner since the disciplinary
39 penalty was imposed.

1 (c) The petition may be heard by the committee. The committee
2 may assign the petition to an administrative law judge designated
3 in Section 11371 of the Government Code. After a hearing on the
4 petition, the administrative law judge shall provide a proposed
5 decision to the committee that shall be acted upon in accordance
6 with the Administrative Procedure Act.

7 (d) The committee or the administrative law judge hearing the
8 petition may consider all activities of the petitioner since the
9 disciplinary action was taken, the offense for which the petitioner
10 was disciplined, the petitioner's activities during the time the
11 license or approval was in good standing, and the petitioner's
12 rehabilitative efforts, general reputation for truth, and professional
13 ability. The hearing may be continued as the committee or
14 administrative law judge finds necessary.

15 (e) The committee or administrative law judge, when hearing
16 a petition for reinstating a license or approval or modifying a
17 penalty, may recommend the imposition of any terms and
18 conditions deemed necessary.

19 (f) No petition shall be considered while the petitioner is under
20 sentence for any criminal offense, including any period during
21 which the petitioner is on court-imposed probation or parole. No
22 petition shall be considered while there is an accusation or petition

20 or the regulations adopted pursuant to Section 3556.4; or (d) it is
21 determined that the participant has not substantially benefited from

responsibilities of a radiologist assistant in the program, and the possible results of noncompliance with the program.

3556.4. In addition to the criteria and causes set forth in Section 3556.2, the committee may set forth in its regulations additional criteria for admission to the program or causes for termination from the program.

3556.5. All committee records and records of proceedings and participation of a radiologist assistant in a program shall be confidential and are not subject to discovery or subpoena.

3556.6. A fee may be charged to participants for participation in the program.

3556.7. If the committee contracts with any other entity to carry out this article, the executive officer of the committee shall review the activities and performance of the contractor on a biennial basis. As part of this review, the committee shall review files of participants in the program. However, the names of participants who entered the program voluntarily shall remain confidential, except when the review reveals misdiagnosis, case mismanagement, or noncompliance by the participant.

3556.8. Participation in a diversion program shall not be a defense to any disciplinary action that may be taken by the committee. This section does not preclude the committee from commencing disciplinary action against a radiologist assistant who is terminated unsuccessfully from the program under this section. That disciplinary action may not include as evidence any confidential information.

Article 8.7. Osteopathic Radiologist Assistants

3557. (a) Notwithstanding any other provision of law, radiologists licensed by the Osteopathic Medical Board of California may use or employ radiologist assistants provided (1) each radiologist assistant so used or employed is a graduate of an approved program and is licensed by the committee, and (2) the scope of practice of the radiologist assistant is the same as that which is approved by the Medical Board of California or the committee for radiologist assistants in the same or similar specialty.

(b) Any person who violates subdivision (a) shall be guilty of a misdemeanor punishable by imprisonment in a county jail not

1 exceeding six months, or by a fine not exceeding one thousand
2 dollars (\$1,000), or by both that imprisonment and fine.

3 SEC. 2. No reimbursement is required by this act pursuant to
4 Section 6 of Article XIII B of the California Constitution because
