An act to add Article 8.3 (commencing with Section 999.90) to Chapter 6 of Division 4 of the Military and Veterans Code, relating to military and veterans.

LEGISLATIVE COUNSEL'S DIGEST

AB 557, as amended, John A. Pérez. Veterans: National Guard: California Interagency Council on Veteran Services and Programs.

Existing law provides certain protections and benefits for veterans and members of the National Guard.

This bill would create in state government the California Interagency Council on Veteran Services and Programs, composed of specified members, for the purpose of bringing together key state agencies and departments, federal officials, legislative representatives, local governments, and stakeholder organizations to ensure that the state's programs that serve veterans are efficiently administered and properly integrated with federal and local government and other stakeholder organizations.

Vote: majority. Appropriation: no. Fiscal committee: yes.
State-mandated local program: no.

The people of the State of California do enact as follows:

SECTION 1. Article 8.3 (commencing with Section 999.90) is added to Chapter 6 of Division 4 of the Military and Veterans Code, to read:

Article 8.3. California Interagency Council on Veteran Services
and Programs

999.90. The Legislature hereby finds and declares all of the following:

(a) The care of veterans and our National Guard members and their families cannot be neglected, especially while the country remains at war.

(b) The needs of California's over two million veterans and their families are diverse and the challenges they face are many. The issues, including, but not limited to, supportive housing, homelessness, mental health, and job training, affect veterans from the World War II and Vietnam eras to younger veterans returning from Operation Iraqi Freedom and Operation Enduring Freedom.

(c) While the federal government has a primary role in providing for the care of our veterans, the programs and services offered by the federal government do not address the needs of many of our veterans in a comprehensive manner, and consequently the gaps in service are increasingly defaulting to state and local providers.

(d) A 2009 audit performed by the Bureau of State Audits found that the Department of Veterans Affairs provides few direct services to veterans, outside of its operation of the Veterans' Homes of California and the CalVet Farm and Home Loan program, and that the department has extremely limited interaction and few formal agreements with other state agencies and departments that could provide additional services to veterans if done in a coordinated and efficient manner.

(e) The 2009 audit additionally noted that the Department of Veterans Affairs strategic plan covering the 2007–08 to 2011–12 fiscal years, inclusive, was incomplete and has not formally assessed veterans' needs, has not included key stakeholders in its strategic planning process, and has not effectively measured its progress towards meeting the goals and objectives identified in the plan.

1 (f) The 2009 audit additionally confirmed that California's
2 veterans participate in collecting federal disability and pension
3 benefits at rates that are significantly lower than those in other
4 states with large veteran populations. These disability payments
5 are paid directly to the veterans and generate a significant
6 contribution to California's economy.

7 (g) The California Research Bureau recently estimated that there
8 are approximately 29,000 homeless veterans currently in California,
9 and it has been reported that veterans make up over 20 percent of
10 the homeless population. It has also been reported that Operation
11 Iraqi Freedom veterans and Operation Enduring Freedom veterans,
12 and increasingly women veterans, are becoming homeless sooner
13 than veterans from the Vietnam era. Unfortunately, the CalVet
14 Farm and Home Loan program only provides benefits to veterans
15 who want to purchase single-family homes, which does not serve
16 the growing needs of our homeless veteran community and their
17 families, who are increasingly in need of emergency shelter and
18 transitional, multifamily, and supportive housing programs.

20 (a) "Council" means the California Interagency Council on
21 Veteran Services and Programs.

22 (b) "Stakeholder organization" means a nonprofit organization
23 whose primary mission is to serve veterans or members of the
24 National Guard, or both.

25 999.92. There is hereby created in state government the
26 California Interagency Council on Veteran Services and Programs.

27 999.93. (a) The council shall consist of all of the following
28 members:

29 (1) The secretary or director, as applicable, or his or her designee
30 with decisionmaking authority, from each of the following:

31 (A) Service and volunteering.

29 (b) The Governor shall appoint a ~~chairperson~~ and vice
30 chairperson from among the members of the council.
31 (c) Members of the council shall not receive any compensation.
32 999.94. The purpose of the council is to bring together key
33 state agencies and departments, federal officials, legislative
34 representatives, local governments, and stakeholder organizations
35 to ensure that the state's programs that serve veterans are efficiently
36 administered and properly integrated with federal and local
37 government and other stakeholder organizations.
38 999.95. The council may establish working groups, task forces,
39 or other structures from within its membership or with outside
40 members to assist it in its work. Working groups, task forces, or

1 other structures established by the council shall determine their
2 own meeting schedules.

3 999.96. The council shall do all of the following:

4 (a) In its first year of operation, hold public meetings at least
5 once every month. In its second year of operation, and each
6 subsequent year thereafter, hold public meetings at least once every
7 quarter.

8 (b) Invite appropriate representatives of the federal government,
9 including, but not limited to, representatives of the United States
10 Department of Veterans Affairs, the United States Department of
11 Housing and Urban Development, and the United States
12 Department of Labor to participate in the council.

13 (c) Ensure that state agencies and departments are doing all of
14 the following:

15 (1) Adequately serving the needs of veterans and National Guard
16 members and continuously evaluating whether their programs are
17 accommodating the surge in demand for services from veterans
18 returning from Operation Iraqi Freedom and Operation Enduring
19 Freedom.

20 (2) Coordinating with federal agencies and departments,
21 including, but not limited to, the United States Department of
22 Veterans Affairs, the United States Department of Housing and
23 Urban Development, and the United States Department of Labor
24 to determine whether California is maximizing the use of federal
25 funding available to support veterans programs.

26 (3) Discussing with local governments, the private sector, and
27 stakeholder organizations ways to complement or utilize existing
28 services provided by state and federal veterans programs and
29 potential mechanisms for streamlining the administration of
30 veterans programs across agencies and jurisdictions to reduce
31 duplication, consolidate availability of services, and ease veterans
32 access to services.

33 (4) Soliciting input and suggestions from stakeholder
34 organizations, the business community, the concerned public, and
35 other governmental agencies on the most effective strategies to
36 serve veterans.

37 (5) Identifying best practices from other states in serving
38 veterans.

39 (6) Creating a plan for council actions by the end of the first
40 year after the initial meeting to implement recommendations for

1 policy, regulatory, and resource changes needed to accomplish
2 objectives, as well as each agency's and department's
3 responsibilities on the council.

4 999.97. The council may engage or accept the services of
5 agency or department personnel, accept the services of stakeholder
6 organizations, and accept private or other nonstate funding to
7 operate, manage, or conduct the business of the council.

8 999.98. The council shall operate within the current budget of
9 each department and agency represented. Each department and
10 agency shall cooperate with the council and furnish it with
11 information and assistance that is necessary or useful to further
12 the purposes of this article.
