An act to amend Section 14105.18 of the Welfare and Institutions Code, relating to health care.

LEGISLATIVE COUNSEL’S DIGEST

AB 715, as amended, Galgiani. Health care programs: provider reimbursement rates.

Existing law provides for the Medi-Cal program, which is administered by the State Department of Health Care Services, under which qualified low-income individuals receive health care benefits. The Medi-Cal program is, in part, governed and funded by federal Medicaid Program provisions. Existing law also requires the department to administer various health programs, including the California Children’s Services Program, Genetically Handicapped Person’s Program, Breast and Cervical Cancer Early Detection Program, State-Only Family Planning Program, and Family Planning, Access, Care, and Treatment (Family PACT) Program. Existing law requires provider rates of payment for services under these programs to be identical to the rates of payment for the same service performed by the same provider type pursuant to the Medi-Cal program.

This bill would revise these provisions to, instead, require provider rates of payment for services under these programs to be identical to the rates of payment for the same service performed by the same provider type pursuant to the Medi-Cal program, except with regard to hospital inpatient rates of payment, which the bill would require to be

The people of the State of California do enact as follows:

1 SECTION 1. Section 14105.18 of the Welfare and Institutions

3 14105.18. (a) Notwithstanding any other provision of law,
4 provider rates of payment for services rendered in all of the
5 following programs shall be identical to the rates of payment for
6 the same service performed by the same provider type pursuant to
7 the Medi-Cal program, except that hospital inpatient rates of
8 payment shall be 90 percent of the Medi-Cal hospital interim rates
9 of payment, ~~as developed by the department, and these hospital~~
10 ~~rates shall not be subject to any further reductions to Medi-Cal~~
11 ~~rates of payment in effect immediately before September 28, 2008~~

- 2 any of the programs described in subdivisions (a) and (b) may be
- 3 reimbursed at rates greater than the Medi-Cal rate that would
- 4 otherwise be applicable if those rates are adopted by the director
- 5 in regulations.
