An act to amend Sections 71100 and 71103.5 of, and to add Sections ~~71103.6 and 71103.7~~ Section 71103.6 to, the Public Resources Code, relating to the environment.

LEGISLATIVE COUNSEL'S DIGEST

AB 939, as amended, V. Manuel Pérez. Environment: New River Water Quality, Public Health, and River Parkway Development Program.

Existing law requires the California-Mexico Border Relations Council, contingent upon the execution of an agreement with the City of Calexico to provide the necessary funding, to develop a strategic plan to guide the implementation of the New River Improvement Project containing specified elements.

This bill would require ~~the Natural Resources Agency, in collaboration with the council, to develop a~~ *to establish the* New River Water Quality, Public Health, and River Parkway Development Program to coordinate the funding *for*; and implementation of ~~activities related to New River, conduct a feasibility study on the construction of a sewage treatment and pollution prevention project in the City of Calexico, and complete various activities necessary to develop a river parkway plan for New River in the city. The bill would require state agencies providing funding for activities related to New River within the city, to the extent feasible, to coordinate the award and management funds pursuant to the California River Parkways and Urban Streams Restoration Grant Programs~~

~~guidelines~~, specified recommendations from the strategic plan, and certain programs and projects identified by the council. The bill would require state agencies that fund the activities of the New River Improvement Project to make all necessary efforts to integrate and align their contractual and administrative requirements for financial assistance support to meet the goal of this program.

The people of the State of California do enact as follows:

- 5 (a) "Agency" means the California Environmental Protection
- 6 Agency.
- 7 (b) "Cal BECC" means the California Border Environmental
- 8 Cooperation Committee established on July 22, 1994, by the
- 9 Governors of California, Baja California, and Baja California Sur.
- 10 (c) "California-Baja California border region" means the region
- 11 described in Chapter IV of the US-Mexico Border XXI Program,
- 12 Framework Document, published October 1996.
- 13 (d) "City" means the City of Calexico, California.
- 14 (e) "Council" means the California-Mexico Border Relations
- 15 Council established pursuant to Section 8711 of the Government
- 16 Code.
- 17 (f) "County" means the County of Imperial, California.
- 18 (g) "Fund" means the California Border Environmental
- 19 Education Fund established pursuant to Section 71101.
- 20 (h) "IBWC" means the International Boundary and Water
- 21 Commission, United States Section.
- 22 (i) "New River Improvement Project" or "project" means a

1 SEC. 2. Section 71103.5 of the Public Resources Code is
2 amended to read:

3 71103.5. (a) The Legislature finds and declares all of the
4 following:

5 (1) The New River poses an imminent and severe threat to the
6 public health of residents of Calexico, California, and adjacent
7 communities in the County of Imperial. Since the 1940s, the New
8 River has been recognized as a significant pollution and human
9 health problem, primarily because of extremely high concentrations
10 of fecal coliform bacteria.

11 (2) While there have been recent measurable water quality
12 improvements as a result of sewage infrastructure projects
13 implemented and completed during the last 10 years in Mexicali,
14 Mexico, the residual and projected pollution in the New River
15 coming from Mexico remains a significant threat to public health
16 and the environment.

17 (3) Current bacteria levels in the New River are several orders
18 of magnitude above the state standards for bacteria. Based on these
19 levels and the historic levels of pollution, the waterway is believed
20 to carry pathogens that cause tuberculosis, encephalitis, polio,
21 cholera, hepatitis, and typhoid. The waterway also carries other
22 contaminants in concentrations that are in violation of federal,
23 state, and Mexican water quality standards by several hundredfold.

24 (4) The New River is listed as an impaired river by the United
25 States Environmental Protection Agency due to low dissolved
26 oxygen (DO) and the presence of chlordane, chlorpyrifos, copper,
27 dichloro-diphenyl-trichloroethane (DDT), diazinon, dieldrin,
28 mercury, nutrients, pathogens, polychlorinated biphenyls (PCBs),
29 sediment, selenium, toxaphene, toxicity, trash, and volatile organic
30 compounds (VOCs).

31 (5) The New River is a major contributor of pollution to the
32 Salton Sea, and failure to address water quality problems in the
33 New River are impeding the ability of the state to implement laws
34 and programs designed to restore and protect this important
35 environmental and wildlife habitat resource.

36 (6) The New River condition in the border area is also an
37 aesthetic nuisance for Calexico residents and has historically
38 inhibited the city's socioeconomic well-being and growth.

39 (7) A coordinated and comprehensive state strategy is needed
40 to deal with the residual and projected pollution so that the New

1 River and associated river channel can be enhanced to a condition
2 that will allow the residents of Calexico and Imperial County to
3 utilize them as recreational and natural assets as contemplated in
4 the California River Parkways Act of 2004 (Chapter 3.8
5 (commencing with Section 5750) of Division 5).

6 (8) In the Budget Act of 2009, as amended by Chapter 1 of the
7 Statutes of 2009 Fourth Extraordinary Session, eight hundred
8 thousand dollars (\$800,000) was appropriated to the City of
9 Calexico for various planning needs necessary to develop a river
10 parkway plan and river improvement project for the New River.
11 The moneys were appropriated in order to secure and serve as
12 matching funds for the four million dollars (\$4,000,000) allocated
13 pursuant to the Safe, Accountable, Flexible, Efficient
14 Transportation Equity Act: A Legacy for Users (Public Law
15 109-59) to the City of Calexico for the development of bicycle
16 paths and public park space adjacent to the New River.

17 (9) The City of Calexico, as the recipient of funding pursuant
18 to the California River Parkways Act of 2004, has agreed to provide
19 necessary financial support to the council for the development of
20 the council's strategic plan.

21 (b) Pursuant to the authority granted to the council under Section
22 8712 of the Government Code and contingent upon the execution
23 of an agreement with the City of Calexico for the purpose of
24 providing the necessary funding, the council shall develop a
25 strategic plan to guide the implementation of the New River
26 Improvement Project. The strategic plan shall include, but need
27 not be limited to, all of the following elements:

28 (1) Quantification of current and projected New River water
29 quality impairments and their threat to public health.

30 (2) Prioritization of the actions necessary to protect public health
31 and to meet New River water quality objectives and other
32 environmental goals, such as improving the quality of water flows
33 into the Salton Sea.

34 (3) Identification of potential funds for the implementation of
35 the project, and potential lead agencies that would be responsible
36 for environmental review of activities related to the cleanup and
37 restoration of the New River.

38 (4) Identification of the appropriate federal, state, and local
39 agencies with a role in implementing and achieving the New River
40 Improvement Project.

1 (c) (1) To the extent permitted by law, the council may work
2 with appropriate binational, federal, state, local, and
3 nongovernmental organizations on both sides of the
4 California-Mexico border to develop the strategic plan and to fund
5 and establish cooperative water quality monitoring, public health
6 studies, inspection, and technical assistance programs as needed
7 to support, convene, and oversee the project.

8 (2) To further the objectives of this subdivision, the council
9 may convene and oversee a technical advisory committee. The
10 advisory committee shall advise the council regarding the necessary
11 studies and activities to carry out the project, and shall serve at the
12 pleasure of the council. The advisory committee shall include
13 representatives from the following:

- 14 (A) Impacted cities and counties.
- 15 (B) Relevant local, regional, and state agencies and departments.
- 16 (C) Nongovernmental organizations.
- 17 (D) Other stakeholders deemed necessary by the council.

18 (3) The council shall appoint the chair of the committee and
19 may expand the membership and expertise of the committee as it
20 deems necessary.

21 (4) The council may enter into an agreement, including an
22 interagency agreement and memorandum of understanding, with
23 public agencies, including the city, to accept, manage, and expend
24 funds for the implementation of this section.

25 (d) This section does not modify existing roles, responsibilities,
26 or liabilities of the State of California, the City of Calexico, the
27 County of Imperial, or any other governmental agency, under those
28 laws that regulate, protect, and clean up surface waters entering
29 the United States from Mexico.

30 (e) The New River Improvement Project Account is hereby
31 created in the California Border Environmental and Public Health
32 Protection Fund to receive moneys for activities related to the New
33 River Improvement Project from sources identified in Section
34 71101 and other sources. Upon appropriation by the Legislature,
35 moneys in the account shall be expended to implement the purposes
36 identified in subdivision (c) or Section 71102 that are related to
37 the New River.

38 SEC. 3. Section 71103.6 is added to the Public Resources Code,
39 to read:
