An act to amend Section 52461 of the Education Code, relating to career technical education, and making an appropriation therefor.

LEGISLATIVE COUNSEL'S DIGEST

AB 2033, as amended, Salas. Agricultural career technical education: *grant* funding.

~~(1) Existing law provides funding for various career technical education programs, including regional occupational centers and programs, specialized secondary programs, partnership academies, and agricultural career technical education programs. Existing law establishes the Agricultural Career Technical Education Incentive Program, pursuant to which requires the Superintendent of Public Instruction is authorized to award grants to a grant, for the purpose of~~

purchasing or leasing agricultural career technical education equipment, to an applicant school districts for purposes relating to district that operates an agricultural career technical education programs. program and that meets specified requirements.

Existing law requires the governing board of each school district to annually adopt or update a local control and accountability plan that contains specified information.

This bill would appropriate the sum of \$4,134,000 from the General Fund to the State Department of Education for purposes of funding the Agricultural Career Technical Education Incentive Program. This bill would require the Superintendent to award a grant to a school district that, in addition to meeting the existing requirements, demonstrates how the expenditure of the grant funds will be consistent with its adopted local control and accountability plan. The bill would also express various findings and declarations of the Legislature relating to agricultural career technical education.

~~(2) Funds appropriated by this bill would be applied toward the minimum funding requirements for school districts and community college districts imposed by Section 8 of Article XVI of the California Constitution.~~

1 (3) The Agricultural Career Technical Education Incentive
2 Program has provided financial incentives for school districts to
3 embark on a systematic and sustained process for improving the
4 delivery and effectiveness of agricultural education throughout
5 California.

7 (4) The Future Farmers of America organization, which is
8 integral to high school instruction, has long proven itself as an
9 outstanding teaching strategy that promotes excellence in

12 is to teach and promote premier leadership, personal growth, and

15 (5) The Future Farmers of America has a long and
16 well-established tradition of providing meaningful, relevant
17 leadership development experiences that have had a positive effect
18 on the lives of thousands of pupils in their communities.

21 innovative and expanding science, technology, engineering, and
22 agricultural industries has been made possible through the
23 availability of well-trained and educated personnel.

25 (7) Cocurricular pupil leadership organizations enhance the
26 classroom instruction process, provide opportunities to learn in a
27 laboratory, and provide leadership training opportunities.

28 *(b) It is the intent of the Legislature that funds appropriated for*
29 *the Agricultural Career Technical Education Incentive Program*
30 *in the annual Budget Act shall be no less than the amount*
31 *appropriated during the 2013–14 fiscal year.*

 2 Public Instruction that the grant funds received and the matching
 3 funds contributed by the *school* district shall be used solely for the
 4 purpose of purchasing or leasing equipment for use in agricultural
 5 career technical education programs.

 7 *of the grant funds will be consistent with its local control and*
 8 *accountability plan adopted pursuant to Article 4.5 (commencing*
 9 *with Section 52060) of Chapter 6.1.*
